Request for Qualifications (RFQ) for Engineering Services

The County of Tyler is seeking to enter into a services contract with well qualified engineering service provider(s) to assist the County in preparing an application for and in the overall management of its proposed Disaster Recovery Reallocation Program (DRRP) grant related to the de-obligated and unutilized Community Development Block Grant for Disaster Recovery (CDBG-DR) funds to provide the opportunity for communities with outstanding unmet need to access remaining CDBG-DR funds , if funded by the Texas General Land Office. The following outlines this request for gualifications:

I. <u>Scope of Work</u> - A sample detailed Scope of Work ("SOW") provided by GLO is enclosed as Exhibit A. The professional engineer to be hired is to provide application and contract-related management services, including but not limited to the following areas:

Pre-Funding Services*

Assist with the development of grant applications, as necessary.

Post-Funding Services

Initial Engineering and Design Support Engineering and Final Design Support Bid and Award Support Contract Management and Construction Oversight Specialized Services

Please specify a complete list of actual tasks to be performed under each of these categories in your response, including, if necessary, a **brief** description of each task

*Pre-funding services are not eligible for CDBG-DR reimbursement and must be paid with local or other non-CDBG-DR funds.

- II. <u>Statement of Qualifications</u> The County is seeking to contract with a competent engineer firm experienced in grants/contracts application. Please provide the following information:
 - A brief history of the proposing entity, including general background, knowledge of and experience working with relevant agencies, with an emphasis on recent experience;
 - Related experience in applying for and managing federally-funded local public works construction projects – road elevation and drainage improvements, retrofit county facilities to withstand higher strength winds, and a hydrologic study to develop hydrology flood plain maps to assist with base flood elevation, establish flood gages in flood plains with an emphasis on directly-related and recent experience;
 - A description of work performance and experience with CDBG-DR including a list of at least three references from past local government clients, with information describing the recency and relevancy of the previous performance and experience;
 - Describe the proposing entity's capacity to perform as well as resumes of all employees who will or may be assigned to provide technical assistance if your firm is awarded this management services contract, identifying current employees and proposed hires; and
 - A statement substantiating the resources of the proposing entity and the ability to carry out the scope of work requested within the proposed timeline.

- IV. For this RFQ, Respondent's qualifications will be evaluated and the most qualified Respondent will be selected.
 - Upon the award of this contract, profit (either %/ actual cost) must be identified and negotiated as a separate element of the price for any contract in excess of \$150,000.
- V. <u>Submission Requirements</u>
 - A copy of your current **certificate of insurance** for professional liability.
 - A statement of conflicts of interest (if any) the proposing entity or key employees may have regarding these services, and a plan for mitigating the conflict(s). Please note that City/County may in its sole discretion determine whether or not a conflict disqualifies a firm, and/or whether or not a conflict mitigation plan is acceptable.
 - **System for Award Management**. Consultant/Firm, and its Principals, may not be debarred or suspended nor otherwise on the Excluded Parties List System (EPLS) in the System for Award Management (SAM). Include verification that the company as well as the company's principals are not listed (are not debarred) through the System for Award Management (www.SAM.gov). Enclose a print out of the search results that includes the record date.
 - Form CIQ, enclosed in Exhibit C. Texas Local Government Code chapter 176 requires that any vendor or person who enters or seeks to enter into a contract with a local government entity disclose in the Questionnaire Form CIQ the vendor or person's employment, affiliation, business relationship, family relationship or provision of gifts that might cause a conflict of interest with a local government entity. Effective January 1, 2016, all contracts and contract amendments, extensions, or renewals executed by the Commissioners Court will require the completion of Form 1295 "Certificate of Interested Parties" pursuant to Government Code § 2252.908. Form 1295 must be completed by awarded vendor at time of signed contract submission. Form 1295 is included in this RFP for your information.
 - **Required Contract Provisions**. Applicable provisions enclosed in Exhibit D must be included in all contracts executed as a result of this RFP.
- VI. <u>Contracting with small and minority businesses, women's business enterprises, and labor surplus area</u> <u>firms.</u> Small and minority businesses, women's business enterprises, and labor surplus area firms are encouraged to participate in this RFQ. If the awarded vendor is a prime contractor and may use subcontractors, the following affirmative steps are required of the prime contractor:
 - 1) Placing qualified small and minority businesses and women's business enterprises on solicitation lists;
 - 2) Assuring that small and minority businesses, and women's business enterprises are solicited whenever they are potential sources;
 - 3) Dividing total requirements, when economically feasible, into smaller tasks or quantities to permit maximum participation by small and minority businesses, and women's business enterprises;
 - 4) Establishing delivery schedules, where the requirement permits, which encourage participation by small and minority businesses, and women's business enterprises;
 - 5) Using the services and assistance, as appropriate, of such organizations as the Small Business Administration and the Minority Business Development Agency of the Department of Commerce.

SCOPE OF WORK

The Contractor shall provide the following scope of services: (choose contracted services)

SCOPE OF SERVICES REQUESTED

Providers will help the GLO fulfill State and Federal Community Development Block Grant Disaster Recovery("CDBG-DR") statutory responsibilities related to recovery in connection with any federally declared disaster. Providers will assist the GLO and/or grant recipients in completion of CDBG-DR qualified housing or non-housing projects. Engineering services must be performed in compliance with the U.S. Department of Housing and Urban Development ("HUD") and guidelines issued by the GLO.

DESCRIPTION OF SERVICES AND SPECIAL CONDITIONS

Respondent must be able to perform the tasks listed herein to be considered eligible for an award under this Solicitation. Respondents should provide a detailed narrative of their experience as it relates to each of the items below. Respondents should clearly indicate if they intend to provide services in-house with existing staff or through subcontracting or partnership arrangements. Engineering Services will be provided in conformance with the guidance documents and use forms provided by the subrecipient utilizing GLO guidance. The providers shall furnish pre-funding and post-funding engineering services to complete the disaster recovery projects, including, but not limited to the following:

- flood control and drainage improvements
- hydrologic study to develop hydrology flood plain maps to assist with base flood elevation
- establish flood gages in flood plains with an emphasis
- road elevation and drainage improvements,
- retrofit county facilities to withstand higher strength winds

Pre-Funding Services

Engineer will develop project scope and complete CDBG-DR application. The provider will work with the subrecipient and Administrator, if applicable, to provide the concise information needed for submission of complete disaster recovery funding application and related documents. The required information shall be submitted in a format to be described by the GLO.

Post-Funding Services

Engineer will complete infrastructure, and eligible projects approved for disaster recovery funding. The selected engineering firm must follow all requirements of the Texas CDBG Disaster Recovery program.

Scope of Work

The engineering contract will encompass all project-related engineering services to the County of Tyler including but not limited ot the following.

- Preliminary and final design plans and specifications;
- Preparation of the bid packet;
- Conduct all field testing and inspections (interim and final); and
- Other special services.

The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 CFR part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition, where the purchase price of the item exceeds \$10,000 or the value of the quantity acquired during the preceding fiscal year exceeded \$10,000; procuring solid waste management services in a manner that maximizes energy and resource recovery; and establishing an affirmative procurement program for procurement of recovered materials identified in the EPA guidelines.
