ORDER ADOPTING 2024 TAX RATE

WHEREAS, on this the 27th day of August, 2024, came on to be considered for adoption the 2024 tax rate of Hardin County, Texas, by the Hardin County Commissioners Court. The following Members were present:

WHEREAS, upon motion made by Commissioner Kirkendall, Precinct No. 2, and second by Commissioner Young Precinct No. 3, it is hereby ORDERED that the Tax Rate for the 2024 Tax Year shall be adopted and set as follows:

- (1) the debt service tax rate is hereby set at \$0.005685 per \$100 valuation
- (2) the maintenance and operation tax rate is hereby set at \$0.496788 per \$100 valuation
- (3) the total tax rate is hereby set at \$0.502473 per \$100 valuation


This total Tax Rate is lower than the rate set for the 2023 Tax Year; and it is the same as the No-New Revenue Tax Rate of \$0.502473 per \$100 valuation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.


THE MAINTENANCE AND OPERATIONS TAX RATE OF \$0.496788 WILL EFFECTIVELY BE LOWER THAN THE NO-NEW REVENUE MAINTENANCE AND OPERATIONS TAX RATE OF \$0.501124 BY 0.86% AND WILL DECREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$37.47.




