- Soda Go – 697 South Main, Lumberton, Tx - All specifications met- earned a perfect score of 100
- Happy Donuts – 114 N. Main St., Lumberton – all specifications were met - earned a perfect score of 100
- Lumberton Hospital, LLC– 137 N. LHS Dr., Lumberton - all specifications were met - earned a perfect score of 100
- Frontier Rodeo Coffee Company Bakery (Commissary) – 9667 Hwy 69 S., Kountze – all specifications were met - earned a perfect score of 100
- Country Corner #1 – 3211 FM 92, Silsbee – no certified Food Manager was on site, no discard date labeling on prepackaged sandwiches in cooler, no thermometers in coolers - earned a score of 94
- Country Corner #2 – 8005 FM 418, Silsbee – no thermometers in coolers - earned a score of 98
- Family Baking Company – 769 S. Main St., Lumberton – all specifications were met - earned a perfect score of 100
- Good Grounds Coffee & Café – 769 S. Main St. Ste. D, Lumberton – ice scoop was not placed on a clean surface or in a clean container, the physical facility shall have a cleaning schedule in place to keep it clean, ice machine was soiled with a substance build up, no food handler certificates were on site for each employee - earned a score of 97
- Big Thicket Country Store - 807 S. Main, Lumberton – the hand sink was not accessible, ware washing sink was unsanitary, wet mops should be placed in a manner for them to dry, most recent inspection report shall be posted in customer view - earned a score of 93
- Dickey’s BBQ – 795 S. Main, Lumberton – utensils & pans were not being cleaned well to rid grease and food particles, cutting boards were pitted and worn & didn’t hold their integrity, shelving racks holding food equipment & food containers must be cleaned to rid grease and food accumulation - earned a 95
- Church’s Chicken – 795 S. Main, Lumberton – no certified Food Manager was on duty at the time of inspection, no food handler certification was held by any employee on duty, discard date labeling on foods were not legible or understood by the employee’s - earned a score of 94
- Super Pak Deli – 16618 FM 770, Saratoga – all specifications were met - earned a perfect score of 100

- Tobacco Barn #89 - 425 S. Main, Lumberton, TX 77657 - All specifications met- earned a perfect score of 100
- SA Food Mart – 1310 North Pine St., Kountze, TX – Scored a 96 – No labels on food in the fridge. No sanitizer testing kit.
- Huneez Cafe – 300 S. Pine, Kountze - All specifications met- earned a perfect score of 100
- Tobacco Barn #89 - 425 S. Main, Lumberton, TX 77657 - All specifications met- earned a perfect score of 100
- SA Food Mart – 1310 North Pine St., Kountze, TX – Scored a 96 – No labels on food in the fridge. No sanitizer testing kit.
