- Chili's Grill & Bar – 1010 Hwy 96 S, Silsbee – cleanliness opportunities in the kitchen (food line, walls, equipment, counters), storage door needs replacing, storage not organized, items on the ground, clean freezer door and sweep, organize and clean label station - earned a score of 95
- Dollar General – 955 Hwy 327, Silsbee – all specifications met – earned a perfect score of 100
- Southern Maid Donuts – 205 W. Ave N, Silsbee – bulb covers missing over lights, clean out closet, tools need to be in a box or kit, clean holders for sprinkles, dates missing on some foods, some wall cleanliness issues – earned a score of 96
- West Texas BBQ – 3078 Hwy 96 N, Silsbee — all specifications met - earned a perfect score of 100
- The Learning Center – 124 Country Lane, Lumberton – all specifications met – earned a perfect score of 100
- Lumberton Donut – 731 N Main, Lumberton – need lid on dining area trash can, need sanitizer strips, spay bottles need labeling, remove homemade may haw jelly, food not dated, need food handler and food manager certifications, floors behind equipment need cleaning, countertops not clean and sanitized, rags on countertop – earned a score of 75
- Domino's – 191 C LHS Drive, Lumberton – air curtain needs replacing, Food Manager Certification not posted, Food Handler Certification needed – earned a score of 94
- Dollar General Store – 319 N Main, Lumberton – men's room no paper towels, ceiling tile missing in restroom and needs cleaning – earned a score of 97
- Dollar General Store – 1015 Pine Street, Kountze – restroom not stocked for handwashing – earned a score of 98
- Diers Drive In – 655 W Ave N, Silsbee - all specifications met – earned a perfect score of 100
- Sonic Drive-In – 106 N. Main, Lumberton – all specifications met – earned a perfect score of 100
- Chicken Express – 520 S, Main, Lumberton – all specifications met – earned a perfect score of 100
- M&D Supply/Ace Hardware – 122 S Main, Lumberton – cooler not at temp, items overstocked to block air flow, cleaning bottle not labeled (corrected on site) – earned a score of 97
- Taco Bell – 239 S Main, Lumberton - all specifications met – earned a perfect score of 100
- Lucky Donut – 570 Hwy 105 E, Sour Lake – no dates on food in cooler – earned a score of 98
- Goodie's Café – 115 Hwy 326 S, Sour Lake - all specifications met – earned a perfect score of 100
- Circle A – 520 Hwy 326 S, Sour Lake – no food manager certification – earned a score of 95
- McDonalds – 610 Hwy 96 S, Silsbee – permits not posted – earned a score of 99

- La Quinta Inn & Suites – 104 NLHS Dr., Lumberton – all specifications met – earned a perfect score of 100
- Batson Grocery & Deli – 42784 Hwy 105, Batson — no Certified Food Manager, no hot water in restroom, Food handler needs certification - a score of 91
- Mama Jack’s – 215 Pine Street, Kountze - all specifications met – earned a perfect score of 100
- Catfish Cabin – 922 S LHS Dr., Lumberton – all specifications met – earned a perfect score of 100 – earned a score of 98
- Gore Family Auction Center – 10905 FM 92, Silsbee - new opening - all specifications met – earned a perfect score of 100
- Katie’s Confections – 134 Pine Plaza, Silsbee - new opening - all specifications met – earned a perfect score of 100
- L & M Grocery – 13123 FM 92, Silsbee – need thermometers in coolers, no handwashing area for employees, restroom not supplies, no Food Establishment Permit displayed, no Food Handler Permit – earned a score of 84
