



## *Oct 2022 – Hardin County Health Inspections*

- Boys And Girls Club ( non-profit, after school program) – 1005 N. 7<sup>th</sup> St., Silsbee – suggested the kitchen staff take an approved Food Handler class, no sanitizer strips being used to measure concentration of the sanitizer, explained how to use sanitizer in the ware washing process of a 3 compartment sink - earned a score of 91
- Silsbee Oaks Nursing Facility – 920 E Ave L., Silsbee – automatic fill sanitizer bottle was empty and was not dispensing sanitizer for ware washing or for sanitizing food and non-food contact surfaces - earned a score of 97
- Talk of the Town - Mobile Food Unit (new to Hardin County) -13920 Hwy 69 North, Village Mills - all specifications met - earned a perfect score of 100
- Little Caesars Pizza – 837 N. Main, Lumberton – grime build up on rim & outside of the flour container, no sanitizer measuring strips were observed for measuring the concentration of sanitizer used for ware washing and wiping food and non-food contact surfaces, thermometers not placed inside coolers & freezers for measuring adequate temperature for foods, pizza sheet pans had old food baked on the surface and rust particles, the hand washing sink was located in a busy walk way and recommended to install a splash guard to keep water from puddling on the floor to prevent a possible slip or fall - earned a score of 89
- Domino’s Pizza – 191 S LHS Dr., Lumberton - all specifications met – earned a perfect score of 100
- Domino’s Pizza – 1330 N 5<sup>th</sup> St., Silsbee – hot water was not observed in the restroom or at the employee hand washing sink near the make line, in the food prep area - earned a score of 97
- Red Bird Brews, LLC – Mobile Food Unit - New to Hardin coffee blends – 24636 Hwy 124, Hamshire - all specifications met – earned a perfect score of 100
- The Buckin’ Bean – MFU - all specifications met – earned a perfect score of 100
- Main Street Café – Lumberton – new business - all specifications met – earned a perfect score of 100
- Goings BBQ – 529 S Main, Lumberton – back door is sticking and will not close without a lot of force, was not closed properly upon arrival – earned a score of 99
- Dickey’s BBQ – 795 S. Main, Lumberton – hand sink in the dish room not in service, employees not wearing hats or hairnets at time of entry – earned a score of 97
- Eagles on the Way – 42784 Hwy 105, Batson – no hot water in restroom sinks, cleanliness issues in store area; boxes on the floor, shelves need cleaning, very dusty; the vent-a-hood system is has an expired date and needs to be in compliance in case a fire breaks out, must have a trash can with a lid for the women’s restroom – earned a score of 95

- Honky Tonk Grill – 2307 Hwy 96 N, Silsbee – no certified food manager on site at time of inspection, no dates on portioned foods in fridge or freezer, missing some thermometers in coolers – earned a score of 94
- Granna’s Griddle – 8381 FM 1003, Kountze - all specifications met - earned a perfect score of 100
- Papa John’s Pizza – 209 South Main, Lumberton – No Food Manager on duty, all lids on the main pizza prep line equipment were broken and in need of repair - earned a score of 96
- Hardin Youth Soccer Concessions -7836 Park Rd, Lumberton - all specifications met – earned a perfect score of 100
- Moore House BBQ – MFU (New To Hardin County) – 2665 Aero Dr. Pt Arthur - all specifications met – earned a perfect score of 100
