



March 2024 – Hardin County Health Inspections

- Burger King - 112 S LHS Dr., Lumberton - all specifications met - earned a perfect score 100
- McDonalds – 1103 N Main, Lumberton - all specifications met - earned a perfect score 100
- Wendy’s – 518 S. Main, Lumberton - all specifications met - earned a perfect score 100
- Dickey’s BBQ – 795 S. Main, Lumberton – can opener and holder had accumulated food and grim buildup, all shelving in need of wiping grim and food accumulation, ceiling was dirty and in need of a deep cleaning or replacement if cleaning is not possible, plumbing leak under ware washing sink – earned a score of 93
- Church’s Chicken – 795 S. Main, Lumberton – pans are to be air dried and placed in draining position, plumbing leak under ware washing sink – earned a score 98
- Chicken Express – 520 S. Main, Lumberton - replace damaged ceiling tile by monitor, cleaning of walk in cooler needed and removal of ice buildup on fan area from a previous cooler issue – earned a score of 99
- Popeye’s Chicken – 108 S. LHS Dr., Lumberton – pans placed on clean drying rack remained greasy and food still remained on the surface, plug lever was missing on ware washing sink causing a water leak, food handler certificates were not available during inspection, the 3 compartment sink area had grease and grim build up in need of a daily cleaning schedule, sponges were discarded and may not be used in food contact areas or washing areas, chicken was being improperly thawed in standing water in buckets on the counter, equipment must be maintained in good repair – several pieces of equipment were not in working order – automatic dish machine, 1 side of the bun water system, hot hold display, 1 side of the fryer were items needing to be repaired or replaced, can opener did not seem to work properly and held grim and food build up and the area holding the opener on the counter, deep cleaning of all shelving and moving equipment on wheels to clean behind, mops should be placed so that they air dry – earned a score of 84
- Southern Maid Donuts – 690 S. Main, Lumberton – employees food handler certificate was expired, removal of rust, grim and debris buildup on shelving, bulk containers and lids, removal of all cardboard used for lining shelves, employee drinks and personal items must be kept separate from food areas, repair or discard cooler in nonworking order – earned a score of 95
- Eagles #13 – 42784 Hwy 105, Batson 77519 – sausage in hot holding equipment was past the time and temperature requirements, ware washing water temperature was below 110 F., thermometers were not observed in all coolers, employee food was commingled with retail foods in cooler, foods in coolers shall be 6 inches above the floor, coolers in need of cleaning – earned a score of 92

- Super Pak Deli – 16618 FM 770, Saratoga 77585 – cooler was not in working order – food was observed at an unsafe temperature and discarded, equipment was tagged out for nonuse until paired or replaced, food items were out of date in the cooler & discarded, thermometer was needed in cooler to monitor temperature, wiping cloths shall be held in a measured sanitizer container when not in use, grease and accumulated dust is to be removed from equipment, louvers were missing in the ventilation equipment – earned a score of 91
- Dairy Queen – 345 Hwy 105 E., Sour Lake 77659 – raw lettuce and raw hamburger were observed on the same tray in the cooler – milk was expired in cooler, thermometer needed in walk in cooler for monitoring temperature, door on prep cooler was broken, double fryer & hot well on the cook line were both out of order - equipment shall remain in working order, cooler in back was not in working order – shall be repaired or discarded, mops shall be placed in a way to air dry, missing ceiling tiles are to be installed – earned a score of 91
- Sonic – 370 E. Hwy 105, Sour Lake 77659 – thermometers shall be visible for employees to monitor, light bulb missing in fryer – earned a score of 97
- Sonic – 106 N. Main, Lumberton 77657 - under the ware washing sink small drain pipe shall have a 1 inch air gap & the larger pipe is wrapped with black tape & not centered resulting in a constant water spill on the floor, wet wiping cloths must be held in properly measured sanitizer container or in container for laundering, small brushes for the cleaning of spouts and tubing were rusty and very worn, cooler & freezer shelving and door gaskets shall be cleaned of soil residues, missing light bulb in fryer, general cleaning of floors and equipment is needed – earned a score of 92
- Whataburger – 401 N. Main, Lumberton 77657 – pipe under ware washing sink is leaking, sponges holding food debris where discarded, pans were stacked tightly within each other not allowing air drying, more frequent cleaning behind equipment, all equipment to include interior and exterior & legs/wheels to preclude accumulation of soil residues – earned a score of 94
- Little Caesars Pizza - 831 N. Main, Lumberton – food handler certifications were not held by food employees - employed over 30 days, prep cooler was not holding a proper temperature - food temperatures were holding at 50 degrees F. & were discarded, ware washing area in need of a frequent cleaning schedule, employees were observed with no hair or beard coverings, facility including equipment & shelving in need of cleaning to rid grim and soil residue, louvers were missing on the ventilation system, wet mops shall be kept in a position to dry, employee restrooms were dirty – earned a score of 88
- Speedy Stop – 755 S. Main, Lumberton 77657 – ware washing temperature was reading 92 F shall be 110 F or above, thermometers missing in coolers, 1 hand sink was not in working order – earned a score of 95
- Schlotzskys Deli – can opener and rollers under the oven rack shall be kept free of encrusted foods, cleaning of shelving, equipment, floors & ceilings shall be cleaned as often as necessary to keep them clean – earned a score of 98
- Pizza Hut – 693 S Main, Lumberton 77657 – food handler certifications were not held by food employees - employed over 30 days, thermometers were missing in the coolers – earned a score 95

- Dairy Queen – 1180 N. St., Silsbee 77656 – not heating prepackaged foods to proper temperature before hot holding, leak in pipe under ware washing sink, air curtain entering cooler have missing flaps, shelving in cooler has signs of chipping and grim, cleaning of ceiling, walls and drains needed, sponges observed with buildup of foods & not allowed for cleaned and sanitize ware washing, puddle of water on the floor by ice cream machine – not draining properly, floor mops shall be placed in a way for drying after use, non-working equipment must be discarded or repaired, old and greasy grill and oven was not in working order – earned a score of 87
- Jack-in-the -Box – 150 Hwy 327 E., Silsbee 77656 – sponges observed with buildup of foods & not allowed for cleaned and sanitize ware washing, air curtain entering cooler have missing flaps, scheduled cleaning of all areas needed on a regular basis to keep facility clean, food manager certificate or food handler certificate must be kept on sight & obtained by any employee working with the food – earned a score of 97
- Donut Palace #1 – 857 N. 5th St., Silsbee 77656 – bottle of cleaner had no name label, food manager certificate or food handler certificate must be kept on sight & obtained by any employee working with the food, thermometers were missing & to be placed to be easily readable in all coolers and hot hold equipment, foods removed from their original package and placed in another container must be name labeled - the bulk containers of food had no food name marking, more frequent cleaning to remove grim and grease on walls, shelving and large bulk containers holding foods, cardboard was being used to cover shelving & tops of equipment and collecting grease – to remove all card board from the kitchen, shall not reuse food grade card board boxes to transport foods, floor mops shall be placed in a way for drying after use, employee personal foods in the cooler were mixed with food establishment foods – earned a score of 90
- Wet Willy’s Daiquiris – 1310 US Hwy 96 S., Silsbee 77656 – all specifications were met – earned a perfect score of 100
- Country Corner # 1 – 3211 FM 92, Silsbee 77656 – prepackaged sandwiches had no date marking, no sanitizer being used in ware washing or wiping cloths being held in a concentration of sanitizer for sanitizing food contact surfaces and non-food contact surfaces, ice machine closed for cleaning - observed black build up inside the unit, ice scoop was placed on unsanitary shelf, cooler thermometer & hot hold thermometer were missing, no sanitizer kit for measuring sanitizer was observed, food contact area counter top was peeling and flaking off debris and was not constructed of a wipe-able & cleanable material, gnats were observed at the ware washing sink area, floor mops shall be placed in a way for drying after use, missing ceiling tiles in kitchen area - earned a score of 87
- Buzzy Bee – 970 Hwy 96 S., Silsbee 77656 – food being held for 4 hours had no times to discard recorded, no sanitizer being used for ware washing no sanitizer strips were observed as being used to measure a concentration of a sanitizer, employee hand no food manager or food handler certification, thermometer missing in walk in cooler & no stem thermometer for temping of foods was being used, no paper towels at the hand sink, drink machine had accumulation of grim on the surfaces & around the nozzle tips, no sink stoppers for holding water to wash and sanitize were available, sponges were discarded with food & grim

- accumulation, ice scoop was placed on unsanitary shelf, first aid kit needed in the establishment, floor mops shall be placed in a way for drying after use – earned a score of 82
- Papa John’s Pizza – 209 S. Main, Lumberton 77657 – waste receptacle to be placed next to the hand sink, restroom to have a lid on the waste receptacle- earned a score of 98
 - Frosty Fountain – 422 LHS Dr., Lumberton – all specifications were met – earned a perfect score of 100 Younger Years - 719 S Main, Lumberton, Tx 77657 - All specifications met- earned a perfect score of 100
 - Rise & Shine East - 292 Country Lane, Lumberton, Tx 77657 - All specifications met- earned a perfect score of 100
 - Rise & Shine West - 271 Hwy 421 West, Lumberton, Tx 77657 - All specifications met- earned a perfect score of 100
 - The Learning Center - 124 Country Lane, Lumberton, Tx 77657 - All specifications met- earned a perfect score of 100
 - Napoli’s Restaurant – 835 S. Main, Lumberton – some prepped items were not labeled in the cooler, earned a score of 98
 - Tejas #3 – 620 Hwy 69 N, Kountze – had raw beef stored above produce in the walk0in cooler, lids need to stay closed at all times on dumpster and area needs to be cleaned around the dumpster, some dusting and cleaning issues in kitchen area, all items corrected on site - earned a score of 95
 - Sno Barn – 42739 Hwy 105, Batson – CFM had expired - earned a score of 98
 - Hwy 96 Truck Stop – 5008 Hwy 96, Silsbee – no system for 4 hour hold on food not temperature controlled, no hot water in restroom sinks, food bagged from bulk must be dated, missing thermometers in some equipment, need to replace faucet for three compartment sink, no hat or hairnet upon arrival, no sanitizer container for wet towels, boxes left on the floor, food was thawing on the counter, need a covered trash can for women’s restroom - earned a score of 81
 - Walmart – 1100 Hwy 96 N, Silsbee - all specifications were met – earned a perfect score of 100
