- Tia Juanita’s – 322 S. Main, Lumberton – raw chicken was stored above bacon and brisket in WIC, bulk containers need to be labeled and no utensils left inside, shelves need to be cleaned – earned a score of 93
- Pho Nomenal – 113 #C NLHS Dr., Lumberton – found raw beef over lettuce in the WIC, Food Manager had left and was not on site while I did the inspection, missing dates on items in the coolers, missing thermometers in coolers, employee food, phone and drink on food preparation station (corrected on-site), towels on the counter and no sanitizer buckets in use, thawing brisket in a sink and not under running water, mop on the ground in the kitchen – earned a score of 87
- Burger King – 112 S. LHS Dr., Lumberton – employee had a tongue ring and one needed hair restrained, rules must be followed in the food prep area – earned a score of 99
- Popeye’s Louisiana Kitchen – 108 S LHS Dr., Lumberton – kitchen area full of debris and grease on floor and counters – needs to be cleaned and swept when business is slow - earned a score of 99
