



## *July 2023 – Hardin County Health Inspections*

---

- Sonic – 860 Hwy 96 S., Silsbee -deep cleaning of the facility is needed– earned a score of 99
- Sunshine Grocery – 8511 Mormon Church Rd., Silsbee –not reheating meats correctly, no sanitizer being used for ware washing or wiping counters, label and date marking of prepared foods or food taken from original packaging not observed, removal of unnecessary equipment not in use – earned a score of 89
- Exxpress Mart #14 – 383 North LHS Dr., Lumberton – food observed on the hot hold display after time & temperature had expired, no sanitizer being used for ware washing or wiping counters, date and labeling of time & temperature-controlled foods in cooler, employee food on counter not in designate employee item area – earned a score of 88
- Taco Bell – 239 S. Main, Lumberton -all specifications met – earned a perfect score of 100
- KFC – 815 Hwy 69 S., Silsbee- replace gasket on top of kitchen exit door- closing the space for entry of insects, air vents on the ceiling and all the facility in need of grease and grime build up removal, light bulbs on the ventilation units are not working - earned a score of 97
- Village Creek Coffee Company – 1180 Highway 96 S., Silsbee - all specifications met – earned a perfect score of 100
- Casa Ole – 915 Hwy 96, Silsbee- hot water did not reach adequate temperature for ware washing, air curtains for the walk - in cooler had missing portions preventing the temperature to remain @ 41 F. degrees or lower, cooler thermometer was broken and in need of replacement, food items in cooler temping too high by the door, foods were placed in ice baths and monitored, wet wiping cloths were laying on the counters not placed in measured sanitizer bucket, linens for laundry pick up were placed on the ground outside the door causing insect attraction, ventilation may not be able to keep up with the steam and heat in kitchen- ventilation to be inspected, – a follow up revisit was performed @ 10 A.M. the following day to temp the cooler foods – all food temperatures were good and cooler temperature was @ 41 F. degrees, thermometer had been replaced, hot water heater was raised for manual & automatic ware washing, deep cleaning had been started, equipment not in working order was cleaned & plugged in to be used - earned a score of 90
- Fuel Max 70 – 15800 Hwy 105, Sour Lake – cooked foods were not being cooled properly for reheating, destruction of fried rice, spray bottles not labeled with cleaner, no certified food manager was on duty – manager came in until employee takes the test no inspection report for customer view - earned a score of 91
- McDonalds 103 N. Main, Lumberton – all specifications were met - earned a perfect score of 100

- Schlotzsky's Deli – 295 Country Lane, Lumberton -all specifications met – earned a perfect score of 100
- Church's Chicken – 795 S. Main, Lumberton - all specifications met – earned a perfect score of 100
- Chicken Express – 520 S. Main, Lumberton – observed can opener accumulation of grim, not sanitizing sink before & after marinating fish in a 3 compartment sink, after mopping to hang mops in a drying position - earned a score of 94
- Eagles on the Way – 42784 Hwy 105, Batson – 3 compartment sink does not have stoppers to hold water for ware washing, mozzarella cheese was expired and discarded, concentration of sanitizer shall be used & measured, ceiling tiles in fryer area are not wipeable & cleanable - earned a score of 91
- Dickey's – 795 S. Main, Lumberton – thermometers missing in coolers, some food baring shelving was dirty, rusty & pitted – not wipeable & cleanable, ceilings are not cleanable - some of the outer layer sheeting are starting to peel back and are dirty, ceiling vents need cleaning, earned a score of 94
- Super Pak Deli – 16618 FM 770, Saratoga – no sanitizer being used for ware washing, and cleaning of counters, no food manager on duty, no cooking until documentation of a certified food manager, date marking of foods were expired and discarded, test kit for sanitizer was not observed - corrected on site, no sink stoppers for the 3 compartment sink, can opener and piping above stove had accumulation of debris and in need of degreasing and cleaning, light above the grill was not working - earned a score of 85
- Sonic - 106 N. Main, Lumberton – ice machine had slim build up, some pans & vegetable slicer had not been cleaned well and stacked on top of each other before air drying, racks holding the clean dishes need cleaning for removal of grim & dust, a good overall deep mopping behind machines was needed, repair is needed for a water line under soda machine with leaking water in traffic area - earned a score of 94
- Whataburger - 401 N. Main, Lumberton – all specifications were met - earned a perfect score of 100
- E-Z Mart (#4264) 5075 Hwy 92 N, Silsbee – all specifications were met - earned a perfect score of 100
