FIRST AMENDED NOTICE OF FORECLOSURE SALE

Notice is hereby given of a public nonjudicial foreclosure sale.

1. Property To Be Sold. The property to be sold is described as follows:

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. 4. <u>Terms of Sale</u>. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale is a nonjudicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the Deed of Trust, dated July 13, 2020, executed by Robert Jon Pitts and recorded on July 17, 2020, as Document No. 202505, Official Records of Blanco County, Texas.
- 6. Obligations Secured. The deeds of trust provide that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to the promissory note in the original principal amount of \$144,000.00, executed by Robert Jon Pitts, and payable to the order of Texas Regional Bank, and all other sums of indebtedness permitted by the deed of trust. Texas Regional Bank is the current owner and holder of the Obligations and the beneficiary under the deed of trust.
- 7. <u>Default and Request To Act.</u> Default has occurred under the deed of trust, and the beneficiary has requested me, as one of the Substitute Trustees, to conduct this sale.
