OPTION 1 - Pay Your Ticket

Determine your fine by the schedule below AND

- 1. Payments Online (must be made in full) at: <u>https://www.govrec.com/home/blancocotx</u> **NO Reply Form Submission is needed**
- Criminal Search-->options to search by: Citation Number or Name and DOB
- 2. Payments made by: CASHIER'S CHECK OR MONEY ORDER (No personal checks accepted):
- -Make payable to: BLANCO COUNTY -Submit filled out and signed Reply Form (Section A only) -Copy of citation, postmarked by the appearance date noted on your ticket

OPTION 2 – Deferred Disposition (Article 45.051 CCP) *25 mph and over OR 95 mph or higher ineligible*

*For CDL holders or the speed exceeds 25 mph over the limit, you are NOT eligible for deferred disposition. *

If you qualify for deferred disposition and granted by the court, you will be assessed fees and placed on unsupervised probation (duration not to exceed 180 days). If at the end of probation, you have complied with the terms of your probation, your case will be dismissed. You must submit: Reply form (plea) to the Court, copy of driver's license, proof of liability insurance with accused as a covered driver on policy through citation date, and driving record for this option.

Ages 16-20 years old will be required to take "Alive at 25" with deferral option.

Ages 21-25 years old will be required to take a Driver's Safety Course with a deferral option.

25 mph and over OR 95 mph or higher ineligible OPTION 3 - Driving Safety Course

To be APPROVED FOR DSC COURSE-you MUST do ALL of the following:

- COMPLETE Section A and B, answer True or False statements and have SIGNATURE NOTARIZED. 1
- Email or Mail: NOTARIZED FORM (reply form), Proof of Insurance, driving record (Section C), copy of valid driver license. 2. All items must be postmarked by your appearance date and mailed to the Judge at the P.O. BOX address. SEE ADDRESSES BELOW.
- 3. REQUEST TYPE 3-A DRIVING RECORD FROM DPS WEBSITE: www.dps.texas.gov/DriverLicense/driverrecords.htm
- The Judge's court will notify of approval THEN defendant will be able to submit payment of \$146.00 after approval. 4

NOTE OPTION 3 IS NOT AVAILABLE IF YOU HAVE: A COMMERCIAL DRIVER LICENSE,

VIOLATIONS OF 25 MPH OR MORE OVER POSTED SPEED LIMIT. OFFENSE(S) IN CONSTRUCTION ZONE AND/OR WORKERS ARE PRESENT OR FOR SOME SCHOOL BUS AND ACCIDENT VIOLATIONS

OPTION 4 - Ask for Trial You will be notified by mail of trial date - you MUST notify court if your address changes You must send:

1. Completed REPLY FORM (see other side) see Section A Option 4, NOT GUILTY plea and desired: Bench Trial or Jury trial

Submit a copy of your Driver's License, completed Section A (include your phone number) with signature and date of signing.

OPTION 5 - Do Nothing A phone call is NOT an appearance; you MUST enter a written plea in person, by mail or email!

After your appearance date passes and you have failed to appear or enter your plea in court, you may be charged with an additional violation of Violate Promise to Appear or Failure to Appear. Warrants will be issued for your arrest.

The renewal of your Driver's License may be Denied, and you will be turned over for collections. Additional fees will be applied.

For citation dismissals of: insurance, registration, inspection or driver's license violations contact court for fees and documentation.
