Cypress Dr., Johnson City, Blanco County, Texas, and simulcasted live online at www.YouTube.com , channel “Blanco County”, at which time the following subjects shall be discussed and action considered and/or taken thereon:

Call to order and roll call.

Pledge of Allegiance(s).

Invocation.

PUBLIC COMMENTS— opportunity for the general public to address the Court on any agenda item. Comments are limited to 3 minutes.

1. Consider approval of minutes of prior Commissioners Court meeting(s). Vote on any action taken. (Judge Bray)
2. Consider ratifying and/or approving line-item transfers as presented. Vote on any action taken. (Judge Bray)
3. Consider ratifying and/or approval of the outstanding bills. Vote on any action taken. (Judge Bray)
4. Consider proclamation declaring June 14, 2025, as “Flag Day” and June 8 - 14, 2025, as “Flag Week” in Blanco County. Vote on any action taken. (Judge Bray)
5. Discussion and possible action to authorize the City of Johnson City to utilize the north parking lot of the north annex for fireworks display on July 4, 2025, pending burn ban status and drought conditions and parking areas on the north side of courthouse and south side of the north annex for a street dance. Vote on any action taken. (Judge Bray)
