Approve the Caldwell County Reports:

A. Tax Collection Report for the Month of February 2009 – Judge Wright.

Judge Wright reviewed the Tax Collection Report. Motion made by Commissioner Madrigal, seconded by Commissioner Bullock, to approve the Tax Collection Report for the month of February 2009. Motion carried unanimously.

Discussion/Action to consider Outdoor Burning Ban for Caldwell County – Judge Wright.

Motion made by Commissioner Roland, seconded by Commissioner Madrigal, to leave the Outdoor Burning Ban on for Caldwell County. Motion carried unanimously.

Discussion/Action to approve the purchase of additional radio equipment for the Caldwell County Unit Road System under Public Safety Interoperable Communications Grant Project (PSIC) – Judge Wright/Jimmy Parker.

Emergency Management Coordinator Jimmie Parker explained that when the radio equipment purchases were first started it was unknown how much would be funded and needed for the grant match. An inventory of department's needs has been done and a plan for purchases that everyone can "live with." It was requested to use all dollars set aside for the grant match and purchase radios for Unit Road costing approximately \$57,947.50. There was discussion concerning the type of radios and maintenance of these radios. The dollar amount of monthly payment to be a part of the Austin Channel is still not known. Luling and Martindale are paying their part of the grant match. Motion made by Commissioner Bonn, seconded by Judge Wright, to approve the purchase of twenty mobile radios at \$1,870.00 each and approve the purchase of eight portable radios at \$1,163.00 each. Motion carried unanimously.

Motion carried unanimously.

Discussion/Action to present and consider a resolution to support the creation of sub-committees of the complete count committee for the Census in 2010 – Judge Wright/Noemi S. Azoubel.

Sofia Azoubel presented information concerning the 2010 census. She explained the savings of federal tax payer dollars by promoting awareness so the response rate of the initial mail out to residences are responded to. She stated tax payers dollars are saved when community is involved in this census. Motion made by Judge Wright, seconded by Commissioner Madrigal, to approve the Resolution to Support the Creation of Sub-Committees of the Complete Court Committee for the Census in 2010. Motion carried unanimously.

Motion made by Commissioner Roland, seconded by Commissioner Madrigal, to approve bills totaling \$121,650.88. Motion carried unanimously.


