7. Discussion/Action to consider a Proclamation to designate the month of February 2010 as Black History Month-Commissioner Roland.

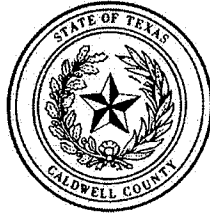
