07.22.07 Reports.

- A. Annual Report from AgriLife Carissa Wilhelm, Caldwell County Extension Agent and Michael Haynes, Caldwell County Extension Agent. Carissa Wilhelm, Caldwell County Extension Agent said that they were pleased to have had reached almost 7000 citizens with over 250 activities and projects throughout the County during 2012. She said that there was an increase of 15% membership for 4-H in the County. She was very pleased as other Counties are reporting a downward trend of 10%. She recognized the Caldwell County 4-H Scholarship winner's Alex Lindsey and Morgan Vondohlen, who received both, a County and a State Scholarship. Both students will be attending Texas A & M this fall. Judge Bonn thanked her for the work she does with 4-H and the County. Michael Haynes, Caldwell County Extension Agent described 2012 a recovery year for Caldwell County ranches and farmers after 2011. He explained the Range Management Program which is designed to provide producers with information through these difficult times. He said there was substantial growth and noticeable achievements in the Caldwell County Junior Livestock shows and awards throughout the state. He answered Commissioner Madrigal's question regarding the egg production, informing that egg production is still a multimillion dollar industry. Caldwell County is a large egg production area.
- B. Update on the Animal Services Contract with City of Lockhart Larry Roberson, Caldwell County Auditor.
 Larry Roberson explained that the new cost for the County's share of the contract is to be budgeted at \$130,000.00. There was an increase bringing the costs to \$115.00 per dog and \$64.54 per cat. This includes \$11,000.00 for the lease on the new facility.
- C. Tax Collection Larry Roberson, Caldwell County Auditor. Larry Roberson, Caldwell County Auditor reported the Tax Collection for the month of June 2013.
- D. Radio System Maintenance Larry Roberson, Caldwell County Auditor; Larry Roberson, Caldwell County Auditor reported the increase of \$5,164.00 per year. This annual amount covers the service and software for the radios in the County. The County covers the costs for the Volunteer Fire Departments as well.
- E. Weight/Scales Margarito Zapata, Constable Precinct No. 3/Art Villarreal, Constable Precinct No. 4. Constable Zapata gives report on the status of the weight/scales and the assistance that may be available from Precinct 4 in the future. He is concerned with the safety of the vehicle used to transport the weights. Judge Bonn told him to take the vehicle to the vehicle maintenance for new tires. More updates are expected.

07.22.15 Budget Workshop.

Judge Bonn began the workshop by reviewing the items discussed in the past meetings. Commissioner Muñoz asked about Enviromental Task Force, page 37. Judge Bonn described the past situation with the colonies of mobile homes and one meter and extension cords. Kasi Miles replies that there has not been a recent problem. Decision was made to strike all lines except training, lab fees, and equipment for a total of \$5,000.00. There has not ever been any activity to this in the past budgets. Larry Roberson gave an overview of the budget changes that were discussed in this meeting. They were County Court at Law Judge, Radio Communication, and Animal Control. Commissioner Roland said that he would like see (4) in the line item for Commissioners, Larry Roberson suggests a supplemental schedule that shows the amount of employees for all departments, so that anyone looking at the budget could tell how the amount budgeted would be split. He will speak to Deborah Kortan, Human Resource Director to work on that. Commissioner Roland discussed the listed maintenance, this line is for Fleet Maintenance department and Larry Roberson explains that there is no budget for Fleet maintenance and the employee that is doing it is not budgeted. The amounts may have to come from Unit Road. Judge Bonn and Commissioner Muñoz agree to get together with Larry Roberson to prepare costs to show Commissioners Court at next meeting. Commissioner Roland said that he was not aware that Fleet maintenance would remain at the new Judicial Center after the renovation. Judge Bonn says that it has been in the plans.
