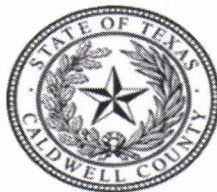


2. **Adjournment.**
