- (a) A person whose license has been suspended for a cause other than a physical or mental disability or impairment or a conviction under Section 49.04, Penal Code, may apply for an occupational license by filing a verified petition (approved by District Attorney's office) with the clerk of the county court or district court with jurisdiction in the county in which:
- (1) The person resides; or
- (2) The offense occurred for which the license was suspended. (note: felony offenses must go back to the convicting court and if a person's license has been automatically suspended based on a conviction must go to the convicting court)
- (b) A person may apply for an occupational license by filing a verified petition only with the clerk of the county court or district court in which the person was convicted if:
- (1) The person's license has been automatically suspended or canceled under this chapter for a conviction of an offense under the laws of this state; and
- (2) The person has not been issued, in the 10 years preceding the date of the filing of the petition, more than one occupational license after a conviction under the laws of this state.
- (c) A petition filed under this section must set forth in detail the person's essential need.
- (d) A petition filed under Subsection (b) must state that the petitioner was convicted in that court for an offense under the laws of this state.
- (e) The clerk of the court shall file the petition as in any other civil matter.
- (f) A court may not grant an occupational license for the operation of a commercial motor vehicle to which Chapter 522 applies.

- 3. Complete the Petition for Occupational Driver's License and Order and take to the **District**Attorney's Office @ 1703 S. Colorado, Lockhart, TX 78644. You can obtain the forms from the Justice of the Peace office.
- 4. The District Attorney's Office will review your Petition and Order and if approved, you will return the Petition and Order to this Court with the filing fee of **\$54.00**.
- 5. If granted, you will receive **two (2) certified copies** of the Petition and the Order. Mail one set to the DPS along with required documents and keep the other set. You must have a certified copy of the Petition and Order on your person for the entire period that your regular license is suspended.
- 6. Send the following items to **DPS** by mail:
 - Certified copy of the Petition and Order
 - Copy of the SR-22
 - A money order payable to DPS for reinstatement fees or pay online at www.texas.gov for amount due and payment online
 - Send a \$10 money order for a 1-year license or \$20 money order for a 2-year license payable to DPS (occupational license fee).
