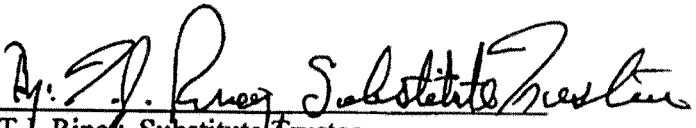
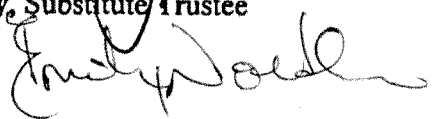
Type of Sale:
