NOTICE OF FORECLOSURE SALE

Notice is hereby given of a public non-judicial foreclosure sale.

1. **Property To Be Sold.** The property to be sold is described as follows:

BEING LOT 6 OF THE RANCHLAND ESTATES ADDITION TO THE CITY OF RETREAT, TEXAS, ACCORDING TO THE OFFICIAL MAP THEREOF ON FILE IN VOLUME 5, PAGE 70, PLAT RECORDS OF NAVARRO COUNTY, TEXAS.

2. **Date, Time, and Place of Sale.** The sale is scheduled to be held at the following date, time, and place:

Date: January 06, 2015

Time: The sale shall begin no earlier than 10:00 A.M. or no later than three hours thereafter.

Place: Navarro County Courthouse in Corsicana, Texas, at the following location: the area designated by the Commissioners Court of Navarro County, Texas, pursuant to § 51.002 of the Texas Property Code as the place where foreclosure sales are to take place (if no such place is so designated, the sale will take place in the area where this Notice of Substitute Trustee's Sale is posted).

The deed of trust permits the Mortgagee of Record to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refiling may be after the date originally scheduled for this sale.

Pursuant to section 51.009 of the Texas Property Code, the property will be sold in "as is, where is" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the deed of trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property.

Pursuant to section 51.0075 of the Texas Property Code, the trustee reserves the right to set further reasonable conditions for conducting the sale. Any such further conditions shall be announced before bidding is opened for the first sale of the day held by the trustee or any substitute trustee.

3. **Terms of Sale.** The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the Mortgagee of Record thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. The sale shall not cover any part of the property that has been released of public record from the lien of the deed of trust. Prospective bidders are strongly

urged to examine the applicable property records to determine the nature and extent of such matters, if any.

If the sale is set aside for any reason, the Purchaser at the sale shall be entitled only to a return of the deposit paid. The Purchaser shall have no further recourse against the Mortgagor, the Mortgagee or the Mortgagee's attorney.

4. Type of Sale. The sale is a non-judicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the Deed of Trust executed by Mark Everett Withrow and Donna S. Withrow.

HOME EQUITY FORECLOSURE ORDER

1. On this day, the Court considered Petitioner's Motion for a Default Order granting its application for an expedited foreclosure order. Applicant's application complies with the requirements of Texas Rule of Civil Procedure 736.1.
2. The name and last known addresses of each Respondent subject to this order is Mark Everett Withrow and Donna S. Withrow - 120 Ranchland Road, Corsicana, TX 75110. Each Respondent was properly served with the citation, but none filed a response within the time required by law. The return of service for each Respondent has been on file with the court for at least ten days.
3. The property that is the subject of this foreclosure proceeding is commonly known as 120 Ranchland Road, Corsicana, TX 75110 with the following legal description:
**BEING LOT 6 OF THE RANCHLAND ESTATES ADDITION TO
THE CITY OF RETREAT, TEXAS, ACCORDING TO THE
OFFICIAL MAP THEREOF ON FILE IN VOLUME 5, PAGE 70,
PLAT RECORDS OF NAVARRO COUNTY, TEXAS.**
4. The lien to be foreclosed is indexed or recorded at Instrument No. 249530416 and recorded in the real property records of Navarro County, Texas.

5. The material facts establishing the bases of the foreclosure of the lien because there has been a default or breach of Respondent's obligation under the loan agreement or contract supporting the lien sought to be foreclosed.
6. Based on the affidavit of the Applicant, no Respondent subject to this order is protected from foreclosure by the Servicemembers Civil Act, 50 U.S.C. App. _ 501 et seq.
7. Therefore, the Court grants Applicant's Motion for a Default Order under the Texas Rules of Civil Procedure 736.7 and 736.8. Applicant may foreclosure on the lien described above in accordance with applicable law and the loan agreement sought to be foreclosed.
8. This Order is not subject to a motion for rehearing, new trial, Bill of review or appeal. Any challenge to this Order must be made in a separate, original proceeding filed in accordance with Texas Rule of Civil Procedure 736.11.
