

IT IS THE INTENT OF THESE FIELD NOTES TO DESCRIBE all that certain lot, tract or parcel of land being 10.55 acres in the W. R. Bennett, Trustees to Tim Coffey, Trustee dated September 14, 2001 and recorded in Volume 1541, Page 715 of the Navarro County Official Records in Navarro County, Texas and said 10.55 acre tract being more particularly described by metes and bounds as follows, to wit:

BEGINNING at a set 1/2 inch rebar for corner in the Southwest margin of county road no. SE 0060 and in the Northeast line of the said 215.06 acre tract and same being the Northeast corner of a 10.57 acre tract, surveyed same date and same being North 77 deg 55' 22" West 914.65 feet from the Northeast corner of the said 215.06 acre tract;

THENCE South 77 deg 55' 22' East with the Southwest margin of said road and with the Northeast line of the said 215.06 acre tract a distance of 397.37 feet to a set 1/2 inch rebar for corner in the said line and same being the Northwest corner of a 10.50 acre tract, surveyed same date;


