Being all of that certain lot, tract or parcel of land located in the Sarah Carter Survey, Abstract No. 184, City of Blooming Grove, Navarro County, Texas and being the same tract of land described in Deed from Sharon K. Moore to Earl G. Forrester, II and wife, Sammie Forrester recorded in Volume 1576, Page 443 of the Official Public Records of Navarro County, Texas (OPRNCT). Said lot, tract or parcel of land being more particularly described as follows:

BEGINNING at a ½" iron rod found with cap, in the southwest line of Fordyce Street, at the east corner of this tract and being the north corner of the Randy & Lisa Hollfield 0.272 acre tract of land described in Deed recorded in Volume 1606, Page 450 of the OPRNCT;

THENCE, S 42° 55' 03" W, 121.96 feet along the common line of this tract and the Hollfield tract to a ½" iron rod found at the west corner of the Hollfield tract, same being the north corner of the Ricky and Diane McGraw 0.10 acre tract of land described in Deed recorded in Volume 1296, Page 282 of the Deed Records of Navarro County, Texas (DRNCT);

THENCE, S 42° 17' 49" W, continuing along the common line of this tract and the McGraw tract and also with the Thomas Edward Oliphant 0.101 acre tract of land described in Deed recorded in Volume 1225, Page 209 of the DRNCT, passing a ¾" iron pipe found at 120.40 feet and continuing a total distance of 132.04 feet to a point in the center of an alley way for the south corner of this tract;

THENCE, N 47° 39' 22" W, 118.87 feet along the center of said alley way to a point for the west corner of this tract, same being the south corner of the Don Reed 0.999 acre tract of land described in Deed recorded in Volume 1072, Page 785 of the DRNCT;

THENCE, N 43° 00' 00" E (REFERENCE BEARING), along the common line of this tract and the Reed tract passing a ¾" iron pipe found at 11.65 feet and continuing a total distance of 255.54 feet to a 5/8" iron rod set at the north corner of this tract in the southwest line of Fordyce Street;

THENCE, S 46° 54' 18" E, 117.06 feet along the southwest line of Fordyce Street to the POINT OF BEGINNING and CONTAINING 0.69 OF AN ACRE OF LAND MORE OR LESS.
