**BEGINNING** at a ½" iron rod set on the west right-of-way of County Road No. NE 2010 and the west line of the said 58.625 acre tract, for the southeast corner of this tract, a 1" iron pipe found for the most northerly southeast corner of the 58.625 acre tract bears S30°00'00"W 207.7 feet.
