THIS INSTRUMENT APPOINTS THE SUBSTITUTE TRUSTEE(S) IDENTIFIED TO SELL THE PROPERTY DESCRIBED IN THE SECURITY INSTRUMENT IDENTIFIED IN THIS NOTICE OF SALE. THE PERSON SIGNING THIS NOTICE IS THE ATTORNEY OR AUTHORIZED AGENT OF THE MORTGAGEE OR MORTGAGE SERVICER.

WHEREAS, on July 26, 2013, Bobby Kennedy and Lisa Kennedy, husband and wife executed a Deed of Trust conveying to First National Bank of America, Trustee, the real property hereinafter described, to secure First National Bank of America, in the payment of a debt therein described, said Deed of Trust being recorded in Document No. 00006350, Official Public Records of Navarro County, Texas.

WHEREAS, default has occurred in the payment of said indebtedness, and the same is now wholly due, and the owner and holder of said debt has requested the hereinafter appointed Substitute Trustee to sell said property to the highest bidder for cash and to distribute or apply the proceeds of said sale in accordance with the terms of said Deed of Trust.

NOW, THEREFORE, NOTICE IS HEREBY GIVEN that on Tuesday, March 1, 2016, at 10:00 o'clock a.m. or within three (3) hours thereafter, the Substitute Trustee will sell said real property at the place hereinafter set out, to the highest bidder for cash. The place of sale shall be in the area designated by the Commissioners Court of such County, pursuant to §51.002 of the Texas Property Code as the place where foreclosure sales are to take place (if such place is not so designated, the sale will take place in the area where this Notice of Substitute Trustee's Sale is posted), in the City of Corsicana, Navarro County, Texas.

Said real property is described as follows:

All that certain lot, tract or parcel of land being situated in the Joseph L. French Survey, Abstract No. 286, Navarro County, Texas, and being more particularly described in the Exhibit "A" attached hereto and made a part hereof for all purposes,

including a permanently affixed 1991 Green Hill Mobile Home, Serial # TXFLM12A14266GH and #TXFLM12B14266GH.

The Deed of Trust permits the Beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the Trustee under the Deed of Trust or Substitute Trustee appointed herein need not appear at the date, time and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refiling may be after the date originally scheduled for this sale.

Pursuant to Section 51.009 of the Texas Property Code, the property will be sold in "AS IS, WHERE IS" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the Deed of Trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property and the priority of the lien being foreclosed.

The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Beneficiary thereunder to have the bid credited to the Note up to the amount of the unpaid debt secured by the Deed of Trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the Deed of Trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the Deed of Trust. The sale shall not cover any part of the property that has been released of public record from the lien of the Deed of Trust. Prospective bidders are strongly urged to examine the applicable property records to determine the priority, nature and extent of such matters, if any.

EXHIBIT "A"

BEING a tract of land in the Joseph L. Franch Survey, Abstract No. 286, Navarro County, Texas and being part of a 15.250 acre tract and a 57.146 acre tract of land conveyed to T. W. Stevenson as evidenced by deed recorded in Volume 466, Page 549 of the Deed Records of Navarro County, Texas and being more particularly described as follows:

BEGINNING at a 3/8 inch iron rod found in the West line of Farm to Market Road 667, a 90 foot right-of-way, same being situated approximately N 28°38'00" W a distance of 1247 feet, more or less, from the original South line of said 57.146 acre tract;

THENCE S 61°22'00" W departing the West line of Farm to Market Road 667 a distance of 348.48 feet to a 5/8 inch iron rod set for corner;

THENCE N 28°38'00" W a distance of 250.15 feet to a 5/8 inch iron rod set for corner;

THENCE N 61°22'00" E a distance of 346.21 feet to a 5/8 inch iron rod set for corner in the curving West line of Farm to Market Road 667, said curve having a radius point situated S 57°41'05" W a distance of 1100.92 feet;

THENCE along said curve to the right through a central angle of 3°40'55" an arc distance of 70.75 feet to a 5/8 inch iron rod set for the point of tangency;

THENCE S 28°38'00" E a distance of 178.45 feet to the POINT OF BEGINNING;

CONTAINING within the notes recited 2.00 acres of land, more or less.
