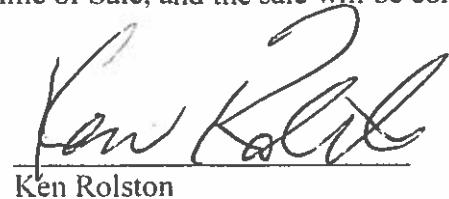

NOTICE OF ACCELERATION OF MATURITY AND INTENT TO FORECLOSE
