1. **Property To Be Sold.** The real property to be sold is described as follows, to wit:

All that certain lot, tract or parcel of land being 4.944 acres situated in the J. B. KETCHUM SURVEY, ABSTRACT 467, in Navarro County, Texas, and being more fully described on Exhibit "A" attached hereto and incorporated herein for all purposes (the "Property").

2. **Date, Time, and Place of Sale.** The foreclosure sale (the "Sale") is scheduled to be held at the following date, time, and place:

**Date:** October 4, 2016

**Time:** The Sale shall begin no earlier than 1:00 P.M., or no later than three hours thereafter. The Sale shall be completed by no later than 4:00 P.M.

**Place:** Temporary Navarro County Courthouse in Corsicana, Texas, at the following location: at or around the east door as prescribed by the Commissioner's Court of Navarro County, Texas.

The Deed of Trust permits the Beneficiary to postpone, withdraw, or reschedule the Sale for another day. In that case, the trustee or substitute trustee under the Deed of Trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be re-posted and re-filed in accordance with the posting and filing requirements of the Texas Property Code. Such re-posting or re-filing may be after the date originally scheduled for this Sale.

3. **Terms of Sale.** The Sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Beneficiary thereunder to have the bid credited to the promissory note (the "Note") up to the amount of the unpaid debt secured by the Deed of Trust at the time of the Sale. Pursuant to the Deed of Trust, the Beneficiary has the right to direct the Trustee to sell the Property in one or more parcels and/or to sell all or only part of the Property. The Property shall be sold on

an "AS IS, WHERE IS" basis. THERE WILL BE NO WARRANTY RELATING TO TITLE, POSSESSION, QUIET ENJOYMENT, OR THE LIKE FOR THE PERSONAL PROPERTY, IF ANY, IN THIS DISPOSITION.

Those desiring to purchase the Property will need to demonstrate their ability to pay cash on the day the property is sold. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the Property.

The Sale will be made expressly subject to any title matters set forth in the Deed of Trust, but prospective bidders are reminded that by law the Sale will necessarily be made subject to all prior matters of record affecting the Property, if any, to the extent that they remain in force and effect and have not been subordinated to the Deed of Trust. Pursuant to Section 51.0075 of the Texas Property Code, the Trustee reserves the right to set further reasonable conditions for conducting the sale. Any such further conditions shall be announced before bidding is opened for the first sale of the day held by the Trustee.

4. **Type of Sale.** The Sale is a non-judicial Deed of Trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the Deed of Trust executed by Perry Shilling and Amy Shilling. The Deed of Trust is dated July 15, 2015, and is recorded in the office of the County Clerk of Navarro County, Texas, under Clerk's File Number 00005837, of the Official Public Records of Navarro County, Texas.

5. **Obligations Secured.** The Deed of Trust provides that it secures the payment of the indebtedness and obligations therein described (collectively, the "Obligations") including but not limited to: (1) the Note in the original principal amount of \$34,475.70, executed by Perry Shilling and Amy Shilling, and payable to the order of Cross Country Cattle Company, Inc.; (2) all renewals and extensions of the Note; and (3) any and all present and future indebtedness of Perry Shilling and Amy Shilling to Cross Country Cattle Company, Inc., who is the current owner and holder of the Obligations, and is the Beneficiary under the Deed of Trust.

6. **Default and Request To Act.** Default has occurred under the Deed of Trust and the Beneficiary has requested me, as the duly appointed Trustee, to conduct the Sale. Notice is given that before the Sale the Beneficiary may appoint another person as Substitute Trustee to conduct the Sale.

**FIELD NOTES

All that certain lot, tract, or parcel of land, being 4.944 acres tract situated in the J. B. Ketchum Survey, Abstract 467, in Navarro County, Texas, and being a part of a 82.778 acres tract described in deed from L. G. Palmer to Raymond Hayes, dated May 24, 1974, recorded in Volume 833, Page 6 of the Deed Records of Navarro County, Texas, said 4.944 acres tract being more fully described as follows:

Beginning at a 1" iron stake for corner, said point hrs. S. 27 degrees 30' E. 1158.2 feet, N. 59 degrees 30' E. 646.3 feet from the original Northwest corner of said 82.778 acres tract;

Thence N. 11 degrees 38' W. 320.2 feet to a point in the center of Private road for corner, which a 1" iron stake hrs. N. 59 degrees 47' E. at 25 feet;

Thence N. 59 degrees 47' E. 706.69 feet to a 1" iron stake for corner;

Thence S. 28 degrees 02' E. 240 feet to a 1" iron stake for corner;

Thence S. 62 degrees 30' W. 147.53 feet to a 1" iron stake for corner;

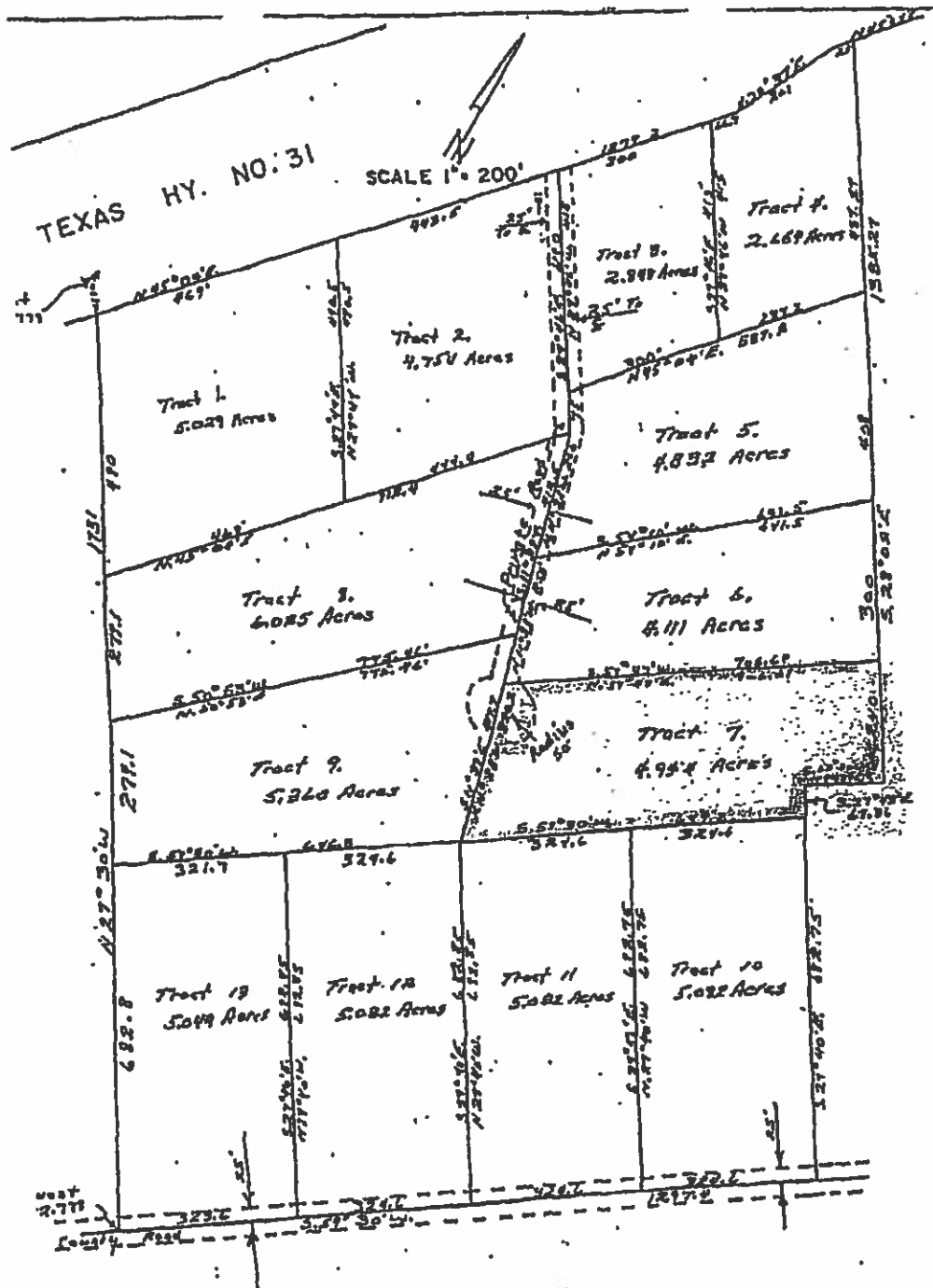
Thence S. 27 degrees 43' E. 67.36 feet to a 1" iron stake for corner;
