All that certain lot, tract or parcel of land, being 5.491 acres, situated in the Michael Shire Survey, Abstract No. 10, Navarro County, Texas, and being a part of the 95 acre tract described in deed from Caroline Benton to Mrs. Lizzie Goldman, dated November 15, 1917, recorded in Volume 202, Page 526, Deed Records of Navarro County, Texas, and described as follows:

BEGINNING at a point in center of County road, the East line of aforesaid 95 acre tract, and being 470 feet N 46 deg. 04' W from the Southeast corner thereof, an iron stake bears 20 feet S 46 deg. 10' W in fence line;

THENCE - S 46 deg. 10' W 871.37 feet to an iron stake in fence on East line of Interstate Highway 45;

THENCE - N 19 deg. 20' W 330 feet with Highway R.O.W. to an iron stake for corner;

THENCE - N 46 deg. 13' E 722.71 feet to the center of County Road, an iron stake bears 20 feet S 46 deg. 13' W in fence line;

THENCE - S 46 deg. 04' E 300 feet with center line of said County road to the place of BEGINNING, containing 5.491 acres, of which 0.137 acre is within the County Road.
