All that certain lot, tract or parcel of land, being 5.407 acres situated in the Michael Shire Survey, Abstract No.10, Navarro County, Texas, and being a part of the 95 acre tract described In Deed from Caroline Benton to Mrs. Lizzie Goldman, dated November 15, 1917, recorded In Vol. 202, page 526, Deed Records of Navarro County, Texas, and being described as follows:

BEGINNING at a point in center of County road on East line of aforesaid 95 acre tract, and being 220 feet N 46 deg 04' W from the Southeast corner thereof, an iron stake bears 20 feet S 45 deg 53' W in fence line;

THENCE --S 45 deg 53' W 997.2 feet to an iron stake in East right-of-way line of Interstate Highway No.45;

THENCE --N 19 deg 20' W 280 feet with Highway R.O. W. to an iron stake for corner;

THENCE --N 46 deg 10' E 871.37 feet to the center of County road, an iron stake bears 20 feet S 46 deg 10' W in fence line;
