**NOTICE OF FORECLOSURE SALE**

Notice is hereby given of a public non-judicial foreclosure sale. SHERRY DOWD, County Clerk

1. Property To Be Sold. The property to be sold is described as follows:

All those certain lots, tracts or parcels of land being Lots Seventy-Nine (79) and Eighty (80) in Block 588 of MILLS ADDITION, City of Corsicana, according to the Plat filed in Volume 1, Page 57, Official Public Records of Navarro County, Texas; said property having a common street address of 2117 West 15<sup>th</sup> Avenue, Corsicana, Texas, 75110.

2. Date, Time, and Place of Sale. The sale is scheduled to be held at the following date, time, and place:

- Date: September 4, 2018
- Time: The sale shall begin no earlier than 1:00 p.m. or no later than three hours thereafter. The sale shall be completed by no later than 4:00 P.M.
- Place: Navarro County Courthouse, at the following location: South entrance along 3<sup>rd</sup> Avenue at Navarro County Courthouse at 300 W. 3<sup>rd</sup> Avenue, Corsicana, Texas 75110, or other place as designated by the Commissioner's Court of Navarro County, Texas.

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. Such reposting or refileing may be after the date originally scheduled for this sale.

3. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. Prospective bidders are strongly urged to examine the applicable

property records to determine the nature and extent of such matters, if any.

4. Type of Sale. The sale is a non-judicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Jose Manuel Camacho, a single person, and notice of said sale has been served to Jose Manuel Camacho. The Deed of Trust is dated October 17, 2008, and is recorded in Instrument No. 9871 (2008), Official Public Records of Navarro County, Texas.

5. Obligations Secured. The deed of trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to (1) the promissory note in the original principal amount of \$54,900.00, executed by Jose Manuel Camacho, and payable to the order of Don Ballew; and (2) all modifications, renewals and extensions of the note. Don Ballew is the current owner and holder of the Obligations and is the beneficiary under the deed of trust.

6. Default and Request To Act. Default has occurred under the deed of trust, and the beneficiary has requested me as Trustee, to conduct this sale. Notice is given that before the sale the beneficiary may appoint another person substitute trustee to conduct the sale.
