If you **FAIL** to respond to the charge(s) by the **APPEARANCE DATE** shown on the citation an additional charge may be filed against you for **VIOLATE PROMISE TO APPEAR** and **WARRANTS** will be issued for your arrest. Additionally, **FAILURE TO APPEAR** or **FAILURE TO SATISFY A JUDGEMENT** ordered by the court may result in the denial of driver's license renewal.

A JUVENILE who **FAILS TO APPEAR** by the time and date on the citation **MAY** have their license suspended.

NOTE: JUVENILES 16 AND UNDER MUST CONTACT THE COURT WITH A PARENT OR GUARDIAN

Warrant fees will be assessed for executing or processing a warrant.

To exercise such right, please fill out the below form.

You may **contact the Court** if you are unable to pay the amount owed without undue hardship to yourself or your dependents. You may request a hearing before the Judge to consider your ability to pay and request any non-monetary compliance options available to you. You should be prepared to explain and document your financial situation to the court.

- _____ GUILTY – I hereby enter a plea of GUILTY and waive appearance for trial.
_____ NOLO CONTENDERE – I hereby enter a plea of NOLO CONTENDERE and waive appearance for trial. *(a plea of Nolo Contendere means you DO NOT contest the State's charges against you. The fine for a plea of Nolo Contendere is the same as that for a plea of Guilty.)*
_____ NOT GUILTY – I hereby enter a plea of NOT GUILTY and request the Court advise me of my trial date by mail.

REQUEST FORM FOR DRIVING SAFETY COURSE

Holders of **COMMERCIAL DRIVER'S LICENSES** are **NOT** eligible for D.S.C. or Deferral.

*Under the laws of the State of Texas, you may request that one charge against you be dismissed by taking a driving safety course or motorcycle operator training course. **HOWEVER, YOU WILL LOSE THIS OPTION IF YOU DO NOT REQUEST IT IN PERSON OR IN WRITING BY YOUR APPEARANCE DATE AS SHOWN ON YOUR CITATION.**

NOTE: The court **DOES NOT** accept a telephone call as an appearance.

This option is available if you hold a valid Texas Driver's License or permit (NOT COMMERCIAL DRIVERS LICENSE), or are a member of the U.S. Armed Forces on active duty with an out of state driver's license AND show proof of financial responsibility (insurance).

This option is NOT available if you are **charged with speeding 25mph or more above the posted limit or speeding 95mph or more in any zone**; have used this option within the last year to dismiss a charge, or are charged for a violation occurring in a work zone with workers present.

If you wish to use this option to have this citation dismissed, complete the request form at the bottom of this page and return it to the Court with the required items/information listed below ON OR BEFORE your appearance date. Once you have been approved to take the course, you will receive a letter in the mail with all information needed to complete and return proof of completion to the Court.

1. COPY OF YOUR TEXAS DRIVER'S LICENSE
2. COPY OF YOUR VALID INSURANCE
3. CASHIER'S CHECK OR MONEY ORDER FOR \$146.00 MADE PAYABLE TO NAVARRO COUNTY
4. THE FOLLOWING AFFIDAVIT POSTMARKED ON OR BEFORE YOUR APPEARANCE DATE

Please initial beside all that apply.

- I hereby plead NOLO CONTENDERE GUILTY
- I possess a valid TEXAS driver's license or permit other than a commercial driver's license.
- I am am not a member of the U.S. Armed Forces on active duty and have and out of state driver's license.
- I am NOT in the process of taking a driving safety course to dismiss another offense.
- I have not completed a driving safety course that is not yet reflected on my driving record.
- I am NOT charged with going 25mph or more above the posted limit or speeding 95mph or more in any zone.
- I am NOT charged with any offense committed in a work zone with workers present.
