Announcements. Items or comments from Court Members or Staff.

Commissioner Muñoz wanted to remind people that on April 18th, the Gaslight Baker Theater is having their 15th Annual Gala. He has tickets available for those who are interested. Commissioner Moses stated he was at the Roughneck Cookoff in Luling who had 54 teams entered. The car show was going on at the same time but due to the rain, it wasn't a very big turnout but still nice. Commissioner Madrigal said Unit Road had some emergencies the past couple of weekends including a sink hole. He called Unit Road and within an hour had received service without accidents. Unit Road also took care of a road at a cemetery when called at the last minute. He thanked the Unit Road Department for their response. Commissioner Roland attended Bunny Land in Lytton Springs this past Easter weekend stating that Lytton Springs is really picking up. He also attended the Athletic Banquet for Lockhart High School and is amazed that the school is jumping by leaps and bounds for the kids with all kinds of awards. Judge Schawe met with the Texas Commission on jail standards down at the jail and received a letter upon inspection acknowledging the work of the Caldwell County Sheriff's Office with a certificate of compliance. 2015.04.13.13

Discussion/Action to approve or disapprove a Resolution expressing support of Caldwell County for legislation related to Goforth Special Utility District. Commissioner Muñoz explained the importance of working together as an area to save the resources of the County. He had been talking with Commissioner Conley from Hays County in regards to a company that drills farther down than normal into the aquifer and sells the water. Civil Attorney Jordan Powell explains further that the Goforth Utility District had signed a contract with a third party that's a "for profit" entity regarding groundwater in the Trinity Aquifer. This allows Goforth to acquire utility easements to turn over to the third party. She states there currently is little legislation stating how much water can be transferred from one to the other which could affect Caldwell County. There are bill proposals currently in front of the legislature that control district limits and the amount of water allowed to be transferred. Commissioner Muñoz and Civil Attorney Jordan

Motion made by Commissioner Muñoz, second by Commissioner Madrigal to approve a Resolution expressing support of Caldwell County for legislation related to Goforth Special Utility District. All Voting "Aye"

Powell both agree the bills need the County's support.

Discussion regarding the purchase of four video recorders for Constable Zapata, Precinct 3, and Constable Villarreal, Precinct 4, in the amount of \$1495.00 each plus installation estimated at \$600.00 Cost: \$6,580.00 (without shipping)

Constable Villarreal explains the need for cameras include for safety purposes as well as to have record of racial profiling for the state. He says it is required to have a camera inside patrol vehicles that conduct traffic stops. Commissioner Madrigal agrees it is important for the protection of officers. Constable Villarreal confirms these cameras are the same ones used by Precinct 1 and are state of the art. Commissioner Muñoz questions where funding for these cameras would come from, therefor Judge Schawe requests County Auditor Debra French approach the Court. County Auditor, Debra French suggest the use of the contingency fund while Judge Schawe states that fund will be used up very quickly. Civil Attorney, Jordan Powell asks if body cams would be a less expensive alternative. Constable Villarreal responds explaining that body cams will not start recording until the officer has approached the individual instead of at the beginning of the initial stop with lights and sirens. Judge Schawe says he would like to see this go through a budget process. Constable Villarreal states he would be satisfied with at least one camera for now until the next budget. Commissioner Madrigal goes on to state that cameras would be cheaper than a lawsuit and should be considered as a necessity and not a luxury. He then requests this item be tabled to the next week's agenda as discussion/action for the purchase of two cameras, one for precinct 3 and one for precinct 4.

Discussion regarding 130 Environmental Park, SOAH Docket No. 582-15-2082; TCEQ Docket No.2015-0069-MSW and related matters. [Executive Session is requested pursuant to Texas Government Code, Title 5, Subchapter D, Section 551.071 (Consultation with Attorney)].

The Court took a 15 minute break and then entered into an Executive Session at 10:00 and ended at 10:46. Persons present in the executive session were: Commissioner Munoz, Commissioner Moses, Judge Schawe, Commissioner Madrigal, Commissioner Roland, Jordan Powell, and Eric Magee. No action was taken in closed session.

The attorney from Allison, Bass & Magee, LLP gave an update regarding 130 Environmental Park, SOAH Docket No. 582-15-2082; TCEQ Docket No.2015-0069-MSW. He confirms that the County did receive party status as of March 26, 2015. The SOAH hearing is set for January 26, 2016 and to last no longer than February 5, 2016. He did want to make a special note that August 3, 2015 is the deadline for parties to file their list of issues for the SOAH hearing.
