Announcements. Items or comments from Court Members or Staff. Commissioner Moses attended the fund raiser for the local Food Bank, \$9,615.00 was raised. Also on February 21, 2015, there will be a tire collection held for the County. This will be in Pct. 2 but for the entire County. The Go Texan Boots & Hearts Country Ball will be this Saturday evening and will raise money for local scholarships. Also March 14 is Caldwell County Day at the Houston Livestock Show and tickets are available. Commissioner Roland attended and enjoyed the Hot Rods & Hatters event this past weekend, on the square. It was a great turnout. Commissioner Madrigal thanked Texas Hatters for all the hard work with local businesses and the Community. Commissioner Muñoz spoke of the loss of a local icon, Lilly Serna. She was very involved with the community and will be greatly missed.

Citizens' Comments. At this time any person may speak to Commissioners Court if they have filled out a Caldwell County Commissioners Court Participation Form. Comments will be limited to four (4) minutes per person. No action will be taken on these items and no discussion will be had between the speaker(s) and members of the Court. The Court does retain the right to correct factual inaccuracies made by the speakers. (If longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day).

1. Jim D. Henderson spoke to the Court in opposition to Resolution 03-2015: Resolution in Opposition to the Application by 130 Environmental Park for Municipal Solid Waste Landfill. Permit Number 2383. Research that he presented shows discrepancies in the geological survey information that was submitted. He asks the Court to not approve the Resolution.

2. James Abshier spoke to the Court and supports Resolution 03-2015: Resolution in Opposition to the Application by 130 Environmental Park for Municipal Solid Waste Landfill. Permit Number 2383. He feels that the landfill could bring economic and ecological disaster to our County. He stated that he was opposed to the extension.

- <u>3. Hoppy Haden</u> encouraged the Court to enter into_a host agreement and is concerned that it could hurt the County's negotiation position if the Court does not begin to work with Green Group. He is against Resolution 03-2015 and stated that TCEQ's findings are different than the findings stated in the Resolution.
- <u>4. Linda Pittman</u> spoke to the Court in opposition of the landfill. She spoke about the damage to wildlife, air and soil for generations to come, calling it a seal of death if approved. Since she requires an oxygen tank, she says that it make the difference in life or death.
- 5. Jessica Neyman spoke in favor of the Resolution 03-2015. Resolution in Opposition to the Application by 130 Environmental Park for Municipal Solid Waste Landfill. Permit Number 2383. She congratulated the Court calling it a bold step. She said that this shows that the Court joins other counties in seeing that the value in land and water are worth more than the immediate fiscal impact. She asked the Court to be firm and fair.
- <u>6. Lou MacNaughton</u> spoke in opposition of the landfill. She asked the Court to be responsible and look at the bigger picture concerning drinking water and the quality of air for generations to follow.
- <u>7. Kathryn Meneley</u> is not only concerned with the air and water quality but belonging to a family of volunteer fire fighters, she is concerned with increased fire safety in the that area from the creation of the landfill. Not only in the event of lightning at the site, but the carelessness of people that throw cigarettes out the windows of vehicles.
- 8. Darrell Scott is concerned that our County Court has other things to worry about than the proposed landfill. There are environmental infractions throughout the County that are being ignored. He spoke about property that had multiple cars and trash on them and other sites with large quantities of trash. He said that there were state agencies with expertise to regulate environmental infractions and he encouraged a host agreement with Green Group Holdings.
- 9. Frank Sughrue asked the Court to reject the extension for Green Group Holdings. He said that they have had 2 extensions already and if the extensions continued that other developers would expect preferential treatment also. He said that there are locations located within the area on the plat that are located over the flood plain. And that he supports the Resolution.
- 10. Sandra Billingsly urged the members of the Court to do their own research on Green Group. She explained that she is not opposed to growth, but that she would like to see compatible growth that would welcome other businesses to the area. She opposes the environmental park.
- 11. Robert D. Kohler stated that he has been a Caldwell County resident for about 14 years. He is concerned about damage to the watershed and the water quality throughout the County. He asked who would take responsibility for the damage that would be done if the landfill is built. He opposes the landfill and asked the court to deny the extension. He is in favor of the Resolution.
- <u>12. Oscar Fogle</u> stated that he is not for or against the project, but has concerns about the preparation and wording of Resolution 03-2015. He explained that he has the confidence and trust in TCEQ, TxDOT, and those with the expertise to make the proper decisions. He urges the Court to not pass Resolution 03-2015.
- <u>13. Byron Friedrich</u> spoke against any extension for Green Group Holdings and he is in favor of Resolution 03-2015. He asked the Court to stand up for Caldwell County and is concerned for the children of future generations.
- 14. Alicia Thornton supports Resolution 03-2015. She has concerns about a host agreement being signed by the Court and not having the right to speak out afterwards.

 15. Jodie Friedrich is in support of Resolution 03-2015 and against any further extensions for Green Group. She believes that it is up to the Court to ensure prosperity for the County.
