The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Hansford County from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that Hansford County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Hansford County is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 9, 2024 AT 10:00 AM AT Hansford County Commissioners Court Room, 16 NW Court, Spearman, Tx 79081.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Hansford County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Hansford County Commissioners Court of Hansford County at their offices or by attending the public meeting mentioned above.
