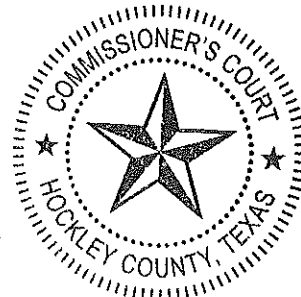


Dear Honorable Judge Baldrige and Honorable Commissioner's Court,
