

Per requirements in Indigent Health Care Service Delivery, McCasland Family Dental agrees to provide dental examination and treatment to persons covered by the County Indigent Health Care (IHC) program. Covered Services are:

- An annual routine dental exam
- Annual routine cleaning
- One set of X-rays per year
- The teast-costly treatment for emergency dental conditions for removing or filling a tooth due to abscess, infection, or extreme pain.

The State has set payment guidelines for IHC based on Medicaid (TMHP) rates. Claims must be filed on a CMS-1500 and mailed to the Indigent Health Care office at 802 Houston, Ste. 109, Levelland, TX 79336.

Appointments will be scheduled by the client who must present an IHC sligibility card at the time of service. Eligibility must be verified by contacting the IHC office at 806-894-4264.

Claims must be filed on a CMS-1500 and malled to the Indigent Health Care office at 802 Houston, Ste. 109, Levelland, TX 79336. Claims must be received within 95 days of the date of treatment to be reimbursed. Any treatment over \$500 must receive prior approval from the Hockley County Indigent Health Care Administrator

Hockley County Sheriff's office agrees to request and honor scheduled appointments for the performance of examinations, treatment and follow up appointments.

A Hockley County Sheriff's Deputy will accompany Inmates and be present for the duration of the appointment.

There will be no set term of the contract. Either party may terminate this contract at any time with or without cause by giving the other party thirty (30) days written notice of termination. This contract may be terminated invalidately for nonpayment.



CONTRACT AND AGREEMENT CONCERNING AMBULANCE SERVICE

THIS AGREEMENT is made and executed by and between the CITY OF LITTLEFIELD, TEXAS, acting through its Mayor, ERIC TURPEN, pursuant to Resolution adopted by the City Council of the CITY OF LITTLEFIELD, at its regular meeting on the 25 day of ______, 2024 (hereinafter called "Littlefield"), and HOCKLEY COUNTY, TEXAS, acting by and through its County Judge, SHARLA BALDRIDGE, pursuant to Resolution adopted by the Commissioners Court of the Hockley County, at a regular meeting on the 25 day of ______, 2024 (hereinafter called "Hockley County"), on the following terms and conditions:

<u>Statement</u>

It is the desire of Hockley County to have Littlefield provide ambulance service, which provides support for the Hockley County ambulance service for the general well-being and welfare of the citizens of Hockley County.

In order to provide such service, it is agreed that Hockley County will pay Littlefield Thirty-Three Thousand Six Hundred Seventeen Dollars and 74/100ths (\$33,617.74) per year in monthly installments. The monthly installments of Two Thousand Eight Hundred One and 48/100ths (\$2,801.48) will be paid with the first monthly payment being made on or before the 5th day of January 2025 and a like payment on or before the same day of each month following next successively thereafter for the term of this Contract.

Terms and Conditions

- (37) The responsibility for operating, contracting, maintaining, supervising, or otherwise conducting the emergency ambulance service shall be the sole responsibility of Littlefield. Provided, however, that Hockley County agrees to indemnify and hold harmless Littlefield, its agents, officers, and employees for any actions, failures, or admissions of anyone performing the ambulance service, as provided herein.
- (38) Littlefield will **not** maintain any type of facilities where ambulances are stored within the County Limits of Hockley County but will continue to operate out of Littlefield's facility in Littlefield, Texas. Therefore, there is a longer response time that may be necessary for the residents of Hockley County, and Hockley County hereby accepts responsibility for any damages that may be caused because of the additional time in responding to any calls.

General Provisions

- (39) The parties agree that each party has the authority to enter into this Contract and such authority has been authorized by the governing body of the Hockley County and the City of Littlefield, respectively.
- (40) The Contract is a term of one (1) year commencing on the 1st day of January 2025 and ending on the 31st day of December 2025.

- (41) Hockley County is paying for the services provided by Littlefield from current revenues available to Hockley County. In this regard, Hockley County represents and warrants that it has budgeted from its current revenues sufficient funds to pay for the cost of the services to be provided by Littlefield.
- (42) Notwithstanding anything to the contrary herein, Littlefield shall not be obligated to perform this Contract if Littlefield does not have the resources to perform the Contract for any reason whatsoever. In the event Littlefield cannot respond or cannot perform this Contract, Littlefield will dispatch the next closest unit.
- (43) Both parties acknowledge that they are authorized to enter into this Contract pursuant to the <u>Texas Government Code</u> and agree that they have complied with all provisions of such Code and other applicable laws to make this a binding Contract between both parties.
- (44) This Agreement is performable in Lamb County, Texas and the parties agree that any suit arising from this <u>Contract and Agreement Concerning Ambulance</u>
 <u>Service</u> shall be brought to Lamb County, Texas.
- (45) The terms of this Agreement cannot be modified except by written agreement signed by all parties hereto.


