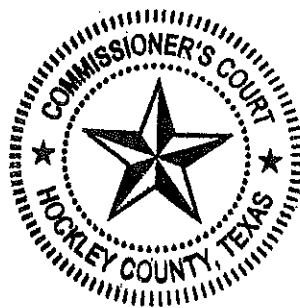

The foregoing Minutes of a Commissioner's Court meeting held on the 6<sup>th</sup> day of August, A. D. 2018, was examined by me and approved.

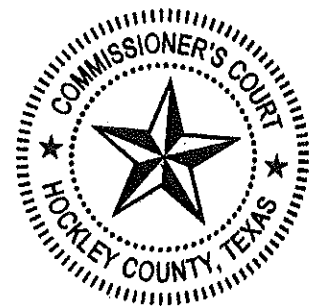
