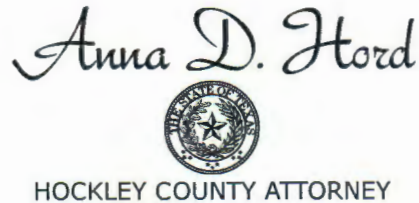

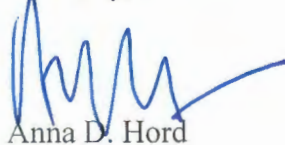
Attached please find a Drug Offense Docket that has been set for February 24, 2025, at 1:30 p.m. This will be held in person in the District Courtroom.
