**DOCKET CALL AND PRE-TRIAL HEARINGS: JULY 5, 2018 AT 1:30 P.M.  
JURY WEEKS: SEPTEMBER 19-21, 2018 AT 9:00 A.M. AND  
OCTOBER 10-12, 2018 AT 9:00 A.M.**

**1. DOCKET CALL**

Cases will be called in the order listed; however, trial of the cases will be in such order as may be deemed convenient by the Court in the interest of efficient judicial administration.

**2. CONTINUANCES**

**ALL MOTIONS FOR CONTINUANCES MUST BE FILED IN WRITING AT LEAST 7 DAYS PRIOR TO DOCKET CALL. ANY CONTINUANCES NOT FILED TIMELY WILL NOT BE GRANTED. NO CONTINUANCES BY PHONE WILL BE ALLOWED.**

**3. PRE-TRIAL MOTIONS AND HEARINGS**

Motions referred to in Articles 28, 39, 46 and other applicable articles of the Code of Criminal Procedure must be filed at least seven (7) days before the date and time set for pre-trial hearing. Pre-trial shall be immediately following docket call unless set otherwise in writing.

Attendance at pre-trial hearing shall be by the defendant, in person or by the attorney who will be trying the case.

Exceptions to the filing deadline for pre-trial motions must be taken up with the Court. All motions not presented at pre-trial are waived. If no written order setting the motions for a time other than immediately following docket call is obtained and filed, motions not heard immediately following docket call are waived.

**4. GUILTY PLEAS**

Pleas of guilty must be announced at Docket Call and shall be disposed of at the next guilty plea docket unless a different date is requested of and set. The County Judge shall be the only one to approve continuances of guilty pleas once they have been set.

**5. TRIAL ON THE MERITS**

Jury selection shall begin at 9:00 a.m. Jury questionnaires are mailed to prospective jurors and returned to the Court Clerk. Copies will be available from the County Clerk as early as practical preceding trial. If you desire to participate in qualifying the jury panel, you will need to be present on the Wednesday of the week of the jury trials.

**6. APPEARANCE**

Bond Forfeiture proceedings will result from the failure of the defendant to appear at Docket Call personally or through his/her attorney in person.

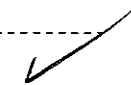
