


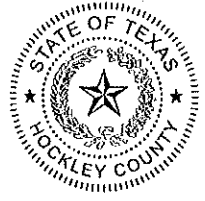



For the avoidance of doubt, the Foreclosure Sale will not cover any part of the Property that has been released of public record from the lien and/or security interest of the Deed of Trust by Riedel Rentals, LLC. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.
