

Expunctions Procedures in Moore County

The person seeking the expunction must include the correct agencies in the application and order of expunction to ensure the person's arrest file is completely expunged.

The following is a list of local agencies that may be involved in the expunction process. Please include the physical or mailing and email address of each agency in your petition. Duplicate agencies will not be notified. **No "issue expunction-certified mail" fee is required if you include the agency's email addresses in the petition/order. This list is not all-inclusive.** You should include any outside agency that has published your information concerning the charge/arrest. For each agency you include **that does not have an email address, you must pay \$25** for the "issue expunction-certified mail" fee, which includes mailing of the notice and order.
