NOTICE OF FORECLOSURE SALE

Notice is hereby given of a public non-judicial foreclosure sale.

In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be re-posted and re-filed in accordance with the posting and filing requirements of the Texas Property Code. Such re-posting or re-filing may be after the date originally scheduled for this sale.

Terms of Sale. The sale will be conducted as a public auction to the highest bidder 3. for cash, subject to the provisions of the deeds of trust permitting the Beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debts secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

Pursuant to section 51.009 of the Texas Property Code, the property will be sold in "as is, where is" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the deed of trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.



- 4. <u>Type of Sale</u>. The sale is a non-judicial deed of trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Ja Mar. The deed of trust is dated March 26, 2010, and recorded in the office of the County Clerk of Moore County, Texas, in Volume 682, page 131 of the Official Public Records of Real Property of Moore County, Texas.

The deed of trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to (1) one promissory note dated March 26, 2010, in the original principal amount of \$51,000.00, executed by Enrique Castillo and wife, Maria de la Luz Baustista, and payable to the order of Polo Carbajal; (2) all renewals and extensions of the note; and (3) any and all present and future indebtedness of Enrique Castillo and wife, Maria de la Luz Bautista to Polo Carbajal. Polo Carbajal are the current owners and holders of the Obligations and are the beneficiaries under the deed of trust.
