Having determined that the courts of the Ninth Administrative Judicial Region require the appointment of an Associate Judge for Child Support Cases,


IT IS THEREFORE ORDERED that Meg F. Jordan is hereby appointed Associate Judge for the Administrative Judicial Region pursuant to Section 201.101, Texas Family Code.

The Associate Judge is to devote full-time service to the duties of an associate judge for child support cases.


IT IS FURTHER ORDERED that this appointment shall be effective from March 12, 2021, and continue in full force and effect for four-years from the date the Associate Judge qualifies for office, unless terminated before that date by further order of the Presiding Judge of this Administrative Judicial Region.

The clerk of the court of any county within the State to which this Associate Judge may be assigned shall record a copy of this order in the Minutes of the Court upon tender of this order by the Associate Judge.
