Your fine is due **BY THE APPEARANCE DATE ON THE CITATION.** Appearance must be in **PERSON OR IN WRITING** on or before the appearance date on the citation. **A PHONE CALL DOES NOT CONSTITUTE FOR AN APPEARANCE.**

If you fail to respond by the appearance date shown on the citation, you will be charged with a **FAILURE TO APPEAR (\$367.00), A WARRANT WILL BE ISSUED FOR YOUR ARREST, YOUR DRIVER'S LICENSE WILL BE SUSPENDED, AND YOU WILL BE SUBMITTED TO A COLLECTION AGENCY.**

If you are an **OUT-OF-STATE VIOLATOR** and you fail to respond to the citation issued, procedures will begin in notifying the licensing authority in your state to **suspend your Driver's License, and you will be submitted to collections.**

#### REQUIREMENTS TO QUALIFY

##### Must not:

1. Be driving 25 mph or over the posted speed limit.
2. Taken a Driver Safety Course in the last 12 months, or currently taking a course for another violation.
3. Driving a Commercial Vehicle, hold a CDL or Out of State Driver's License.
4. Accident with damage to vehicle
5. Failed to render aid
6. Construction or work zone
7. Passing a school bus.
