SUBJECT, HOWEVER TO THE FOLLOWING:

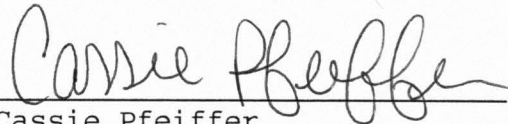

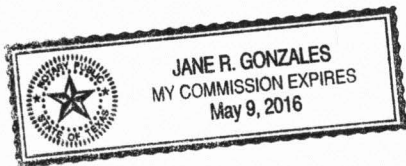

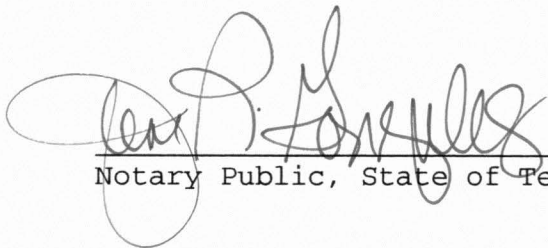
