Background

The Presidio County Sheriff's Office is requesting a budget amendment of \$706.90 to cover the cost of repairing the 2021 Chevrolet pickup which was struck by an El Paso Police Department officer while at the RTC site in El Paso. The County has received insurance claim monies in this amount, however, we should eventually be reimbursed by the City of El Paso for this amount and the \$500 deductible. Repair to this vehicle was not anticipated in the adopted budget.

I have reviewed this information and certify the availability of the funds.

Section 111.070 of the Local Government Code requires commissioners court to spend county funds only in strict compliance with the budget except as follows:

The commissioners court may authorize an emergency expenditure as an amendment to the original budget only in a case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget.

If the court chooses to approve the budget amendment requested above, the following motion should be used:

"I move that the Presidio County Commissioners Court confirm the County Auditor's certification of available funds and, due to unforeseen circumstances, hereby declare and approve an emergency purchase for the repair of the Sheriff's Office vehicle and increase the expenditure budget in accordance with the attached budget amendment form."
