Background

The Presidio County Golf Course is requesting a budget amendment of \$19,467 to cover the cost of replacing the club house roof and three windows. The County has received one quote of \$22,500 for this project. The Golf Course's capital outlay budget balance is \$3,033 so an additional \$19,467 would need to be budgeted for this project. An insurance payment of \$10,598.58 was received in July, 2019 and an additional insurance payment of \$3,204.01 will be received upon completion of the project

I have reviewed this information and certify the availability of the funds in General Fund Balance.

Section 111.070 of the Local Government Code requires commissioners court to spend county funds only in strict compliance with the budget except as follows:

The commissioners court may authorize an emergency expenditure as an amendment to the original budget only in a case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget.
