Background

Presidio County has received notice of a 2021 Operation Stonegarden grant award with a grant period of 3/1/22 to 2/28/23. The award is \$372,195.00 and no match is required from the County. Funds from this grant will be used to pay officer overtime/benefits, temporary deputies, fuel, vehicle maintenance and equipment including a vehicle, automated license plate recognition system costs associated with border security operations operated in conjunction with the U.S. Border Patrol. The grant does not cover benefit costs for the temporary deputies so this amount must be covered by the County. The approximate maximum cost will be the FICA/Medicare match of \$6,700. Since this is an un-budgeted item, a budget amendment is required.

I have reviewed the grant information and certify the availability of this unanticipated revenue.

The budget should be increased in accordance with the attached budget amendment form.

"I move that the Presidio County Commissioners Court confirm the County Auditor's certification of unanticipated revenue for the 2021 OPSG grant in the amount of \$372,195 and increase the Fiscal Year 2022 revenue and expenditure budgets in the same amounts in accordance with the attached budget amendment form."
