Background

In January, the County received \$38,220.52 from the DHS-HSI asset sharing program. This payment is the result of a 2016 asset seizure initiated by the Presidio County Sheriff's Office and referred to DHS-HSI. The funds have been deposited into the Seizures bank account and can be used for law enforcement related purposes. The Sheriff's Office is requesting a budget increase to incorporate these unanticipated funds.

During the repair process, they were informed that their current internet package needed to be updated as the company no longer offered the current plan. The Sheriff's Office would like to upgrade to a midsized plan that offers 12-megabyte streaming speed. The cost would go from \$38.00 per month to \$74.83 per month. The Sheriff's Office is requesting a budget amendment that would move \$295.00 from the Abandoned Motor Vehicles fund to the General Fund that would cover the increased cost for the remainder of the current fiscal year.
