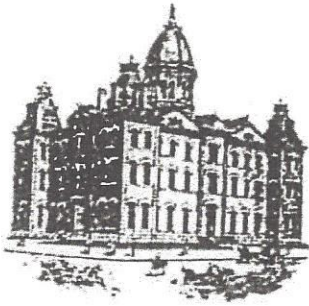

It was reported to me by Richard Newell, USDA.

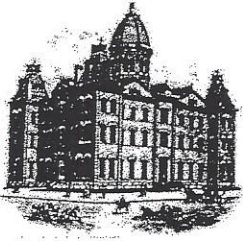
