Pursuant to Rule 165a of the Texas Rules of Civil Procedure and by exercise of the Court's inherent power to manage its docket, all cases on the attached list are scheduled for a hearing on **Wednesday, March 20, 2019 at 9:00 a.m.** in the Liberty County Court at Law in Liberty, Texas. The purpose of the hearing is to determine whether these case(s) should be dismissed for want of prosecution.

If you desire to continue a case(s) on the Court's active, pending docket, you must file a written Motion to Retain setting forth facts and good cause why the case should not be dismissed. You must be present on the date and time of the hearing to present your motion and, if granted, you should be prepared to enter into a Scheduling Order. Some cases may need a Final Order entered.

Failure to file a sufficient Motion to Retain the case or failure to present your Motion to the Court on **March 20, 2019 at 9:00 a.m.** may result in the Court signing an Order Dismissing (the case) for Want of Prosecution.

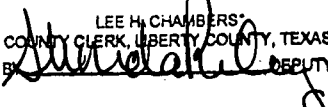
