On this the 11th day of August 2025, the Commissioners Court of Leon County, Texas, met for special called budget meeting directly following regular session with the following members present:

Together with County Clerk Amy Kaiser, serving as an ex-officio member of the Commissioners Court, County Auditor Melissa Abney, County Treasurer Brandi Hill, District Attorney Caleb Henson, Tax Assessor Collector Victoria Willis, and County Attorney Keith Cook.

1. OPEN COURT.

Meeting opened informally without prayer or pledges.

2. DISCUSS AND POSSIBLY TAKE ACTION ON ANY BUDGET ISSUE.

Commissioner Workman made a motion, seconded by Commissioner Foley to state that all of the salary and payroll changes for FY 2024-2025 will take affect on August 4, 2025, instead of August 11, 2025.

MOTION CARRIED.

Judge Ryder made a motion, seconded by Commissioner Workman to rescind the July 28, 2025, Budget Hearing agenda item 2 that stated that ad valorem revenue was to be distributed by road mileage in each precinct.

VOTE BREAKDOWN:

MOTION CARRIED.

Commissioner Foley made a motion, seconded by Judge Ryder to split the ad valorem, motor vehicle, and tax note revenue by 25 percent per precinct for the 2025-2026 fiscal year, with the stipulation that the funds should be spent during the year collected, no rollovers.
