# IN THE COMMISSIONERS COURT OF LEON COUNTY, TEXAS

On this the 5<sup>th</sup> day of August 2025, the Commissioners Court of Leon County, Texas, met for special called budget meeting directly following regular session with the following members present:

Byron Ryder – County Judge Joey Sullivan – Commissioner Pct. No. 1 Paul Bing – Commissioner Pct. No. 2 Kyle Workman– Commissioner Pct. No. 3 T. J. Foley – Commissioner Pct. No. 4

Together with County Clerk Amy Kaiser, serving as an ex-officio member of the Commissioners Court, County Auditor Melissa Abney, County Treasurer Brandi Hill, County Attorney Keith Cook, and Tax Assessor/Collector Victoria Willis.

### 1. OPEN COURT.

Judge Ryder opened the meeting; prayer and pledges to the American and Texas flag were rendered.

#### 2. DISCUSS AND POSSIBLY TAKE ACTION ON ANY BUDGET ISSUE.

Commissioner Sullivan made a motion, seconded by Commissioner Bing to approve the annual 10<sup>th</sup> Court of Appeals payment of \$2075.76.

Commissioner Workman made a motion, seconded by Commissioner Foley to add \$40,000 to the budget to begin assessing a plan to retool the County website for compliance with disability requirements and to increase website functionality for all departments.

Commissioner Workman made a motion, seconded by Commissioner Foley that, effective Aug. 11, County Clerk Amy Kaiser may allocate existing funds in her budget to increase two employee's salary by \$2,000 each.

Commissioner Workman made a motion, seconded by Commissioner Foley, that, effective Aug. 11, County Clerk Amy Kaiser may allocate existing funds in her Records Management budget to create a Chief Deputy Clerk position, increasing that position's salary by \$2,000.

Commissioner Foley made a motion, seconded by Commissioner Workman, that, effective Aug. 11, all full-time employees being paid less than \$32,500 shall be moved up to \$32,500, with any needed funds to be used from Contingency.

Commissioner Foley made a motion, seconded by Commissioner Workman to add \$5,000 to the County Auditor Melissa Abney's salary budget for a part-time shared employee effective the first paycheck of the new budget season.

# **MOTION CARRIED.**

Commissioner Foley made a motion, seconded by Commissioner Workman to define that all pay increases for the new fiscal year become effective the first paycheck of the new budget season, and this includes Juvenile Probation and VCLG.

#### **MOTION CARRIED.**

Commissioner Sullivan made a motion, seconded by Commissioner Foley to keep the current retirement rate at 6.34 for the next budget year.
